PHILOSOPHY/INFORMATION: Our state-licensed Child Care programs provide a safe, supportive environment that promotes social interaction, community integration, physical development, and intellectual growth in accordance with the Maryland State Department of Education's Office of Child Care and National After School Association Standards. School year activities include sports, arts and crafts, games, activity stations, homework time (school-age programs only), enrichments that support STEAM programming (Science, Technology, Engineering, the Arts, and Math), community service projects, and special events. A morning snack and afternoon snack are also included in your monthly fee. The before school program operates from 7:00AM until the start of the school day, and the after school program operates from the end of the school day until 6:00PM every day that school is in session for students. There are also multiple part-time 9am-3pm options available at our South County Rec Pre-K program for 3, 4 & 5-year-olds. A middle school PM program is available at **Crofton MS**. Children in grades 6-8 are eligible to attend the Middle School Teen Group program.

ELIGIBILITY:

- **AGE:** Students 5 years old as of September 5, 2018 through grade 5 (for elementary locations), Students 4 years old as of September 5, 2018 (for Hilltop Pre-K location only) & Students 3 years old as of September 5, 2018 (for South County Recreation Center location only). Children must be toilet trained.
- **STATE MANDATED FORMS:** After completing the on-line registration process, the next step is to download your child's **Forms for Admission** at: <http://www.aacounty.org/departments/recreation-parks/child-care/forms-and-publications/>. Your child's enrollment will not be considered complete until all required forms and the fee have been received by the Child Care Administrative office. Please contact our office if you need these forms mailed to your address. *No one will be permitted to attend without this information on file.*

FEES: Fees are established on a yearly basis as determined by program costs & divided equally on a monthly basis. There is a one-time \$25 registration fee for new children. Please check our website for more information on the site-specific monthly fees. *The first payment is due by July 10, 2018.* We are pleased to accept DSS Purchase of Care Vouchers & NACCRRRA Military Fee Assistance.
