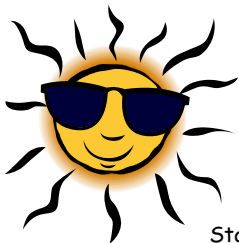


SUMMER SCHOOL AGE CHILD CARE

PHILOSOPHY/INFORMATION: The state-licensed School Age Child Care (SACC) program provides a safe, supportive environment that promotes social interaction, community integration, physical development, and intellectual growth in accordance with the Maryland State Department of Education's Office of Child Care and National After School Alliance Standards. The theme for the 2018 Summer SACC programs is "Adventure Awaits!". Summer activities include sports, arts and crafts, games, activity stations, STEM & Literacy enrichments, special events, and field trips. Morning and afternoon snacks, and field trip T-shirt are also included in your fee. SACC weekly themes & field trips will be posted on our website and emailed to SACC parents prior to February 7, 2018. There is a \$25 non-refundable registration fee for new children and a \$25 non-refundable/non-transferrable deposit for each week that you choose. Please be aware that there is a maximum registration for each center and registration is on a first-come, first-served basis.

ELIGIBILITY:

- **AGES:** Children must be entering 1st through 6th grade to be eligible to attend.
- **STATE MANDATED FORMS:** Every child must have the State mandated forms completed and on file at the site prior to their first day of attending. No one will be permitted to attend without the information on file.
 - **NEW Participants:** You can download the **Required Forms for Admission** on our website. Opportunities to drop off paperwork and meet the summer staff will be announced at a later date.
 - **CURRENT SACC Participants:** Paperwork for current SACC participants will be copied and transferred from your school year site to your summer site. Current SACC parents will only be asked to update forms by the staff on site.
- **TOILETING:** Children must be toilet trained. Your child must be able to be self-directed & self-sufficient in the restroom and able to care for their own hygiene needs.

SUMMER PROGRAM REFUND POLICY:

- The \$25 **registration fee** for new children is non-refundable. All \$25 **weekly deposits** are also non-refundable.
- **10-business days' notice** is required for all summer refunds and payment transfers. Weekly payments (minus the deposit) can be transferred between summer weeks and/or to the 2017-2018 school year.
- Refund requests for medical reasons must be accompanied with a physician's note and are handled on a case-to-case basis.
