NO pets allowed unless service animal as designated by the ADA. No camping or open fires. Take all trash with you when you leave. Cartop launch is available 7 days a week from dawn to dusk with the exception of camp days. From the 3rd week in June-2nd week in August (approx) camp is in session and the launch area is available after 3pm. During large events over 300 people, the launch area may be closed. Call the office or check the website May - August for restrictions. WAIVER - The applicant and all members of his/her group (including guests) understand that open water activites present certain inherent dangers, the risk of which must be assumed by those participating in windsurfing, small craft sailing, canoeing, kite boarding, kayaking, etc. Participants are urged to use the BUDDY system and follow all safety guidelines for the craft they are navigating.
