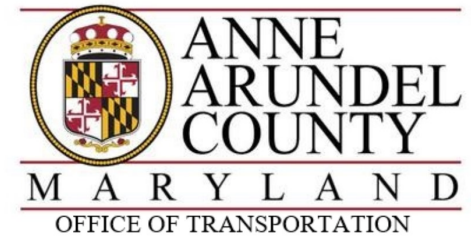
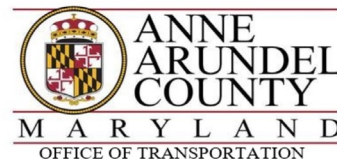

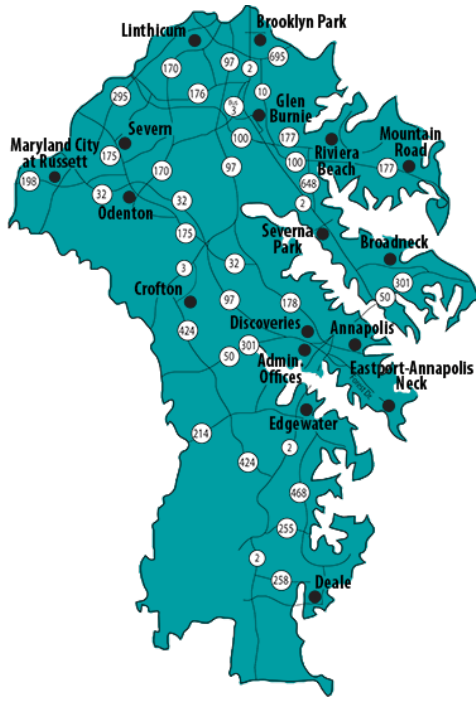

**Eligibility requirements are:**

- ❖ 18 and older with a disability  
*(Must provide SSI Award letter)*
- ❖ 62 if you are currently in the program
- ❖ 65 for all new clients
- ❖ Resident of Anne Arundel County

**All Participants must submit a completed application, with a photo identification with visible Anne Arundel County address.**

Direct address of Destination  
*Destination must be within Anne Arundel County*  
Time/Date of Appointment

**Confirming Your Pick-Up Time:**

The day before your scheduled trip, you **MUST** call after 2pm to get your pick-up time

Pick-up times are just an **estimated** time of arrival. Please be ready at least 15 to 20 minutes before given pick-up time.



**Call 410-222-0022 or 410-222-0225,** our schedulers will need the following:

- Telephone Number
- Home Address
- Mobility
- Destination Address & Phone
- Time of Appointment

If under the age of 65 please provide us with a current Social Security Disability award letter.

Wheelchair transportation is available. However, there is **no escort** service provided to and from the vans. If the client needs assistance a family member or caregiver will be permitted to ride along.
