## About the Program

### What is the Taxi Voucher Service Program?

The Taxi Voucher Service provides discounted coupons to support taxi fares with participating cab companies.

### Who can use the Taxi Voucher Service Program?

Anne Arundel County residents age 65 or older and individuals 18 or older with a disability. Any participants 62 years of age and currently enrolled in the voucher program will still be grandfathered into the program. All persons currently in either program age 55-61 will remain eligible for the accessible taxi program.

### Is there a cost for using the program?

Yes. \$5.00 per booklet.

### How can I get into the Taxi Voucher Service Program?

Easy! Just complete the attached application, order form, provide a current photo I. D. (i.e. valid drivers license or identification card from Department of Motor Vehicles) and enclose your check or money order. Fold the brochure with our address on the outside. Print your return address and add postage. Staple or tape closed to insure privacy and mail.

### Will I have to furnish proof of my annual income?

No.

### What documents do individuals with disabilities need?

Obtain a current Social Security Disability Award Letter (SSDI) from the Social Security Administration Office.

### What happens after I apply?

Once eligibility is determined, you will be mailed an identification card, a coupon re-order form and your taxi voucher booklets.

## Coupons & Cost

### How many coupons can I buy?

You may purchase up to a *maximum of 10* booklets per month.

**NO EXCEPTIONS.** (booklets do not expire)

### How do I know which cab companies participate with the program?

All participating cab companies are listed on the inside of the front and back covers of each coupon booklet.

### How do I pay the taxi company?

Show the taxi driver your ID card and then simply pay at the end of the trip with the taxi coupons.

### Are there any limitations?

Yes.

\*Vouchers can be used ***ONLY*** in Anne Arundel County.

\*Vouchers cannot be used to tip the drivers.
