5	WHEREAS, the Charter Revision Commission appointed pursuant to Section 1203
6	of the Charter has recommended changes to the councilmanic districts now in effect
7	and has forwarded its report to the County Council; and
8	WHIPPEAG A C . C . This A . LL G . C . 207 CA . Cl
9	WHEREAS, the County Council is authorized by Section 207 of the Charter to
10 11	revise, amend, or reconstitute councilmanic districts by ordinance adopted by not less than five of its members; and
12	less than five of its members, and
13	WHEREAS, the County Council determines that it is desirable to revise the
14	councilmanic districts to correct population imbalances which have developed as a
15	result of the 2010 census; now, therefore,
