A BILL ENTITLED

AN ORDINANCE concerning: Beverly Beach Special Community Benefit District -1 Approval of Loan and Assignment Agreement 2 3 FOR the purpose of obligating the County to levy the special tax known as the special 4 community benefit assessment on the Beverly Beach Special Community Benefit 5 District in an amount sufficient to repay a loan from Old Line Bank to the Beverly 6 Beach Community Association, Inc. in each of seven (7) fiscal years during the term 7 of the loan. 8 9 WHEREAS, the Beverly Beach Special Community Benefit District has been 10 duly formed and created, pursuant to procedures set forth in Anne Arundel 11 County Code, Article 4, Title 7; and 12 13 WHEREAS, pursuant to § 4-7-204(i) of the Anne Arundel County Code, the 14 purpose of the Beverly Beach Special Community Benefit District is 15 "maintenance, protection, and repair of the community facilities, including docks, 16 bulkheads, and the littoral currently leased from the County, and defraying the 17 administrative costs associated with completion of the foregoing purpose, 18 including repayment of any loan or interest and any necessary insurance costs"; 19 20 and 21 WHEREAS, the Beverly Beach Community Association, Inc. (the "Association") 22 is the civic or community association that meets the requirements of § 4-7-101(d) 23 that administers the District; and 24 25 WHEREAS, the Association is entering into a loan agreement with Old Line 26

Bank in the amount of \$100,000, with a term of seven (7) years, to be used for

improvements to community facility, mainly to the community playground area (the "Loan"); and

WHEREAS, to enable the Association to obtain the Loan from Old Line Bank by providing a source of funds for repayment of the Loan, the County is undertaking the obligation set forth in this Ordinance; now, therefore,

 SECTION 1. Be it enacted by the County Council of Anne Arundel County, Maryland, That the County shall be obligated to levy the special tax known as the special community benefit assessment on the Beverly Beach Special Community Benefit District in an amount sufficient to repay the Loan from Old Line Bank to Beverly Beach Community Association, Inc. in each of up to seven (7) fiscal years during the term of the Loan, beginning in the County's Fiscal Year 2014.

SECTION 2. And be it further enacted, That the County undertakes no obligation with regard to the Loan except as expressly described in this Ordinance, is neither a co-obligor nor guarantor of the Loan, and does not commit the full faith and credit of the County to repayment of the Loan.

SECTION 3. And be it further enacted, That the County Executive is hereby authorized to enter into such other and further agreements with the Association and Old Line Bank as are necessary to disburse directly to Old Line Bank such amounts of the special community benefit assessment levied on the Beverly Beach Special Community Benefit District as are collected by the County and are necessary to repay the Loan consistent with this Ordinance.

SECTION 4. And be it further enacted, That this Ordinance shall take effect 45 days from the date it becomes law.
