A BILL ENTITLED

AN ORDINANCE concerning: Tax Levies - Arundel Mills Special Taxing District 1 2 FOR the purpose of levying and imposing the tax rates for the Arundel Mills Special 3 Taxing District required by the County Budget for Fiscal Year 2019. 4 5 WHEREAS, by Bill No. 63-98, as amended by Bill No. 101-98, the County 6 Council established the Arundel Mills Special Taxing District and authorized the 7 issuance and sale of certain special obligation bonds to fund certain infrastructure 8 improvements relating to the development and utilization of the land within the 9 Arundel Mills Special Taxing District, all pursuant to Article 24, § 9-1301 of the 10 Annotated Code of Maryland and Article 6, §§ 4A-101, et seq., of the Anne 11 Arundel County Code (1985, as amended) (together, the "Act"); 12 13 WHEREAS, by Bill No. 63-98, as amended by Bill No. 101-98, the County is 14 required to determine the special tax requirement applicable to such district and to 15 levy the special tax for the Fiscal Year 2019; and 16 17 WHEREAS, for Fiscal Year 2019, it has been determined that the debt service on 18 the special obligation bonds, issued in December 1999, or bonds issued in May 19 2004 pursuant to Bill No. 8-04, or bonds issued pursuant to Bill 10-14 to refund 20 such special obligation bonds and other costs related to issuance of such bonds or 21 to the administration of the district, will be paid from sources other than the 22 proceeds of the special taxes; now, therefore, 23 25
