17	SECTION 1. Be it enacted by the County Council of Anne Arundel County,
18	Maryland, That Section(s) of the Anne Arundel County Code (2005, as amended) read

Licensed premises of licensed dispensaries of medical cannabis. 13 14 15 (A) Requirements. Licensed premises of a licensed dispensary of medical cannabis, as defined in COMAR 10.62.01.01, shall comply with all of the following requirements. 16 17 (1) Premises located north of U.S. Route 50 or premises located north of the 18 northeast shore of the South River may not be located within 1,000 feet of a dwelling or 19 residentially zoned property, the lot line of a public or private school, or the lot line of real 20 property owned by the Board of Education. 21 22 23 (2) EXCEPT FOR DISPENSARIES LOCATED IN A BUSINESS COMPLEX ON INDUSTRIAL ZONED PROPERTY, [Vehicular] VEHICULAR access shall be from an arterial or higher 24 classification road. 25 26 (3) "No loitering" signs shall be conspicuously posted in all parking areas. 27 28 29 (4) The premises may not be located within one mile of any other licensed premises of a licensed dispensary of medical cannabis. 30 31 (5) The premises may not have any displays of medical cannabis visible to its 32 customers or the general public. 33 34 (6) The premises may not have an on-site physician for the purpose of issuing 35 written certifications for medical cannabis. 36 37 (B) Variances. A VARIANCE MAY NOT BE GRANTED FOR THE REQUIREMENTS 38 SPECIFIED IN SUBSECTION (A). 39 40 SECTION 2. And be it further enacted, That this Ordinance shall take effect 45 days 41 from the date it becomes law. 42
