12	SECTION 1. Be it enacted by the County Council of Anne Arundel County, Maryland,
13	That Section of the Anne Arundel County Code (2005, as amended) reads as follows:
14	ARTICLE 18. ZONING

16	TITLE 10. REQUIREMENTS FOR CONDITIONAL USES
17	
18	18-10-148. Stables or riding clubs.
19	
20	A stable or riding club shall comply with all of the following requirements.

22	(2) A structure enclosing a horse shall be located at least 50 feet from any
23	nonresidential lot line and [200] 50 feet from any residentially zoned property line.

25	(3) All manure shall be stored at least [100] 50 feet from any lot line.
