A BILL ENTITLED

1	AN ORDINANCE concerning: Finance, Taxation, and Budget - Zoning - Commercial
2	Revitalization District Program – Designation of Commercial Revitalization Area in
3	Ferndale
4	
5	FOR the purpose of designating a certain area a commercial revitalization area; and
6	generally relating to zoning and the commercial revitalization real property tax credit.
7	
8	WHEREAS, § 4-2-306 of the County Code provides that certain commercially-
9	zoned property, industrially-zoned property, and mobile home park property within
10	a commercial revitalization area may be eligible for a certain property tax credit if
11	and when revitalized; and
12	
13	WHEREAS, § 4-2-306(a)(1) defines "commercial revitalization area" as "an area
14	designated on a map adopted by ordinance of the County Council that is eligible to
15	have qualified properties in the area receive revitalization credits"; and
16	
17	WHEREAS, per § 18-14-301, Article 18, Title 14, Subtitle 3 of the County Code
18	applies to the zoning of "commercial revitalization areas as shown on a map
19	adopted by the County Council"; and
20	
21	WHEREAS, by Bill No. 10-17, among other things, the County Council adopted
22	maps of Commercial Revitalization Areas 1 through 8; and

24	WHEREAS, the Office of Planning and Zoning has identified an area along
25	Baltimore Annapolis Boulevard in Ferndale to be designated as Commercial
26	Revitalization Area 9, as shown on the map attached hereto as Exhibit A, as eligible

to have qualified properties in the area receive revitalization credits and to be 1 2 subject to zoning under Article 18, Title 14, Subtitle 3 of the County Code; and 3 WHEREAS, §§ 4-2-306 and 18-14-301 require the County Council to adopt the 4 map of the a designated commercial revitalization area for tax credit and zoning 5 purposes; now, therefore 6 7 8 SECTION 1. Be it enacted by the County Council of Anne Arundel County, Maryland, 9 That the map of Commercial Revitalization Area 9, attached hereto as Exhibit A, is hereby 10 approved and adopted by the Anne Arundel County Council. 11 12 SECTION 2. And be it further enacted, That this Ordinance shall take effect 45 days from the date it becomes law. 13
