## A BILL ENTITLED

1 2	AN ORDINANCE concerning: Approval of the Amended and Restated Lease of County-owned Property to Piney Ice, LLC
3 4 5	FOR the purpose of approving the amended and restated lease of County-owned property identified as 8781 Piney Orchard Parkway, Odenton, Maryland, to Piney Ice, LLC.
6 7 8 9	WHEREAS, the County owns real property identified as 8781 Piney Orchard Parkway in Odenton, Maryland ("the Property"), which is improved with an ice rink; and
10 11 12 13 14 15	WHEREAS, Piney Orchard Master Partnership, a Maryland general partnership, was party to a Lease dated as November 30, 1990, recorded among the Land Records of Anne Arundel County, Maryland in Liber 5226, folio 296, by and between the County, as landlord, and Piney Orchard Master Partnership, as tenant (the "Original Lease") for the Property; and
16 17 18 19	WHEREAS, the Original Lease provided for an initial term of thirty (30) years, with the right to extend the initial term for two (2) additional periods of fifteen (15) years each; and
20 21 22	WHEREAS, Piney Orchard Master Partnership constructed certain improvements on the Property, namely an ice rink; and
23 24 25	WHEREAS, Piney Orchard Master Partnership and the County entered into an Addendum to Lease on December 5, 1995 (the "First Addendum"); and
26 27 28	WHEREAS, Piney Orchard Master Partnership assigned all of its rights, title and interest to Piney Orchard Ice Forum, L.L.C. pursuant to a Deed of Lease

Assignment dated February 15, 1996, and recorded among the Land Records of Anne Arundel County, Maryland in Liber 7322, folio 646; and

WHEREAS, Piney Orchard Ice Forum, L.L.C. changed its name to SkateNation of Piney Orchard, LLC ("SkateNation") pursuant to a name change Amendment filed with the State Department of Assessments and Taxation in Film F3939, folio 2832 on May 22, 1997; and

WHEREAS, SkateNation assigned all of its rights, title and leasehold interest to OR Investment Group, LLC ("OR Investment") pursuant to a Deed of Lease Assignment dated February 28, 2001, and recorded among the Land Records of Anne Arundel County, Maryland in Liber 10262, folio 630; and

WHEREAS, pursuant to an Assumption and Estoppel Agreement dated October 27, 2015, OR Investment assigned all of its rights, title and leasehold interest to the Property to Piney Ice, Inc., a Delaware Corporation qualified to do business in the State of Maryland; and

WHEREAS, Piney Ice, Inc. and the County entered into a Second Addendum to the Lease dated November 2, 2015 amending the Original Lease to, among other things, provide for one additional option period of twenty-five (25) years, such that, provided all options to extend the lease term are timely exercised, the Original Lease expires on November 29, 2075 (the "Second Addendum"; the Original Lease, First Addendum and Second Addendum are collectively referred to as the "Lease"); and

WHEREAS, on January 4, 2016, Piney Ice, Inc. filed with the Delaware Secretary of State a Certificate of Conversion of Piney Ice, Inc. from a Delaware corporation to Piney Ice, LLC, a Delaware limited liability company; and

WHEREAS, the County and Piney Ice, LLC are desirous of amending and restating the Lease, in its entirety, to, among other things, extend the expiration date of the initial term of the Lease until November 29, 2070, permit the addition of a second ice rink on the Property, to allow for the use of turf/sport court material on one of the rinks for all-purpose sports use, to provide for an option to extend the Lease for two (2) additional terms of twenty-three (23) years each, and to secure a performance bond before undertaking any material improvements to the Property, as set forth in the Amended and Restated Lease, incorporated herein by reference as if fully set forth; and

WHEREAS, § 8-3-301 of the County Code requires certain leases of County-owned property in excess of three years, including renewal terms, to be approved by ordinance of the County Council; now, therefore,

SECTION 1. Be it enacted by the County Council of Anne Arundel County, Maryland, That the Amended and Restated Lease, incorporated herein by reference as if fully set forth, which amends and restates the Lease in its entirety is hereby approved.

SECTION 2. And be it further enacted, That the Amended and Restated Lease is incorporated herein by reference as if fully set forth. A certified copy of the Amended and Restated Lease shall be permanently kept on file with the Administrative Officer to the County Council and the Office of Central Services.

SECTION 3. And be it further enacted, That this Ordinance shall take effect 45 days from the date it becomes law.
