5	WHEREAS, Section 1001 of the Charter establishes the Anne Arundel County Ethics Commission, whose members are appointed by the County Executive with
6	the approval of the County Council; and

19	Davis (Republican) for reappointment to the Ethics Commission to serve a term
20	expiring on April 30, 2021; and

22	WHEREAS, the County Executive, subject to the approval of the County Council,
23	has appointed Emerson C. Davis (Republican) to serve a term expiring on April
24	30, 2021; and

27	Davis (Republican) to be qualified under Section 1001 of the Charter to serve on
