1 RESOLUTION approving “Move Anne Arundel!”, Anne Arundel County’s
2 Transportation Functional Master Plan

4 WHEREAS, Chapter 9 of the 2009 General Development Plan, entitled “The
5 Transportation Plan” (“Chapter 9”), provides that the recommendations in Chapter
6 9 “will be evaluated in greater detail through the preparation of a Transportation
7 Functional Master Plan”; and

9 WHEREAS, the recommendations in Chapter 9 included transportation issues
10 related to land use, demand for resources, highway corridor improvements, transit
11 service improvements, changes to facility designs, supporting land use activities,
12 safety, parking, ride share, sources of funding, and intergovernmental coordination;

15 WHEREAS, § 17-6-113(c)(1) of the County Code requires the Office of
16 Transportation, in conjunction with other approving agencies, to prepare a
17 transportation functional master plan no later than one year from November 23,
18 2018; and

20 WHEREAS, the Office of Transportation, in conjunction with other County and
21 State offices and departments, has prepared a transportation functional master plan,
22 entitled “Move Anne Arundel!”, (the “Plan”), incorporated herein by reference as
23 if fully set forth, that addresses the transportation issues identified in Chapter 9 of
24 the General Development Plan, including recommending capital funding priorities;

27 WHEREAS, the Plan has been approved by the Transportation Commission,
28 Planning Advisory Board and the County Executive; now, therefore, be it

30 *Resolved by the County Council of Anne Arundel County, Maryland, That “Move Anne*
31 *Arundel!”, incorporated herein by reference as if fully set forth, is hereby approved as the*
32 *County’s transportation functional master plan; and be it further*


