RESOLUTION approving the declaration of certain non-buildable County-owned property near Island View Drive in Annapolis, Maryland as surplus property

WHEREAS, § 8-3-208 of the Anne Arundel County Code (2005, as amended) (and as amended by Bill No. 79-16) authorizes the County to dispose of County-owned property by private disposition if the property is declared by the Planning and Zoning Officer to be non-buildable, is less than one-tenth of an acre in size, and is determined by the Central Services Officer to be surplus property, and if said determination is approved by the Chief Administrative Officer and by resolution of the County Council; and

WHEREAS, the Planning and Zoning Officer has declared that certain Countyowned property located near Island View Drive in Annapolis, Maryland, as described herein (the "Property"), is non-buildable, the Central Services Officer has determined that the Property is surplus, and the Chief Administrative Officer has approved the Central Services Officer's determination; and

WHEREAS, after a public hearing on this Resolution, the County Council approves the Central Services Officer's determination that the Property is surplus; now, therefore, be it

Resolved by the County Council of Anne Arundel County, Maryland, That in accordance with § 8-3-208 of the County Code, it hereby approves the determination that the property near Island View Drive, Annapolis, Maryland, located in the Sixth Councilmanic District, containing 0.010 acres of land, more or less, is surplus property, being more fully described as:

PARCEL B - Being known as 583 Square Foot SC F. of land beginning for the same at the southeasternmost corner of Lot 211R and the southwesternmost corner of a 5 foot path on the northernmost line of Parcel "A" as shown on the Plat entitled "Amended Resubdivision of Lots 211, 212, 213 and Reserved Area, Section F, Cape St. John" filed among the Plat Records of Anne Arundel County, Maryland in Plat Book 84, page 23; thence leaving said beginning point so fixed and said Lot 211R and running through said Parcel "A" with the westernmost side of a 5 foot easement for ingress and egress to a reserved parcel as shown on said plat and easement now described;
