Good afternoon Chief Wolford,

I would like to sincerely thank John Long Jr. for taking action and I believe saving my life yesterday. I was at Mission BBQ having lunch with my parents and my son around 1130. I took a small fry and threw it in my mouth. I immediately began coughing and then choking. I went to walk outside to try and cough it up. I quickly realized that I couldn't breath and was now gasping for any little bit of air. I walked back over to the table and my dad tried to help me, but he couldn't get his arms around me. My son, Conor, a former police officer, jumped up to help me, but John had already taken over for my dad. I was very light headed at this point and still not able to get any air into my body. I one hundred percent thought "I'm going to die here today in this restaurant". I don't know how many times John did the hiemlich and attempted to get my airway open, but it worked. I was able to breathe again. There was another firefighter with him, I'm sorry I didn't get his name. There were also four Anne Arundel Police Officers there and I didn't get their names either. Everybody was very helpful, but I just wanted John to be recognized for his quick actions. I know he was just doing his job, but it meant the world to me, be-

cause I've never felt like I was going to die before. I'll be celebrating 26 years with the county police on October 5th and I don't know if that would've been possible without John helping me. I thanked John several times and we had a laugh about some things before he left the restaurant. I know he felt good about what he did and sometimes that's enough, but I wanted to take the time to recognize his actions and thank him again from the bottom of my heart. It was a traumatic incident for my family and me. I'm fine now, but it was a really scary moment for me. Thank you for your time.
