4	WHEREAS, § 5-2-104 of the Anne Arundel County Code (2005, as amended)
5	provides that there is a Board of Trustees for the Anne Arundel County Retirement
6 7	and Pension System; and
8	WHEREAS, § 5-2-105(a)(7) of the Anne Arundel County Code (2005, as amended)
9	provides that three of the Trustees shall be residents of the County, may not be
10	employees of the County, may not be participants in any of the retirement or
11	pension plans governed by the Board of Trustees, and shall be knowledgeable in
12	the administration and operation of pension systems and trust funds; and

14	WHEREAS, § 5-2-105(c) of the Anne Arundel County Code (2005, as amended)
15	provides that these three Trustees shall be appointed by the County Executive with the approval of the County Council, given by resolution; and

18	WHEREAS, § 5-2-105(e) of the Anne Arundel County Code (2005, as amended)
19	provides that these three Trustees shall serve for terms of three years, and that, at
20	the end of a term, a Trustee continues to serve until a successor is appointed or
21	elected; and

23	WHEREAS, Alan J. Hyatt completed a term as one of the three Trustees described
24	in § 5-2-105(a)(7) on December 1, 2018, and has continued to serve because no
25	successor has been appointed; and
26	
27	WHEREAS, the County Executive, subject to the approval of the County Council,
28	has reappointed Alan J. Hyatt to serve on the Board of Trustees for a three year
29	term ending on December 1, 2021; and
30	
31	WHEREAS, the County Council, after public hearing, finds that Alan J. Hyatt
32	meets the eligibility requirements under § 5-2-105 of the Anne Arundel County
33	Code (2005, as amended), and is qualified to serve on the Board of Trustees; now,
