12	WHEREAS, efforts to eliminate the structural deficit require the expenditure of one-time costs in Fiscal Year 2018; and

15	WHEREAS, the County Executive has forwarded a request to the State Board of
16	Education for the exclusion of nonrecurring costs pursuant to the Education Article, Section 5-202(d) and COMAR 13A.02.05.03; and

19	WHEREAS, the County Council will work collaboratively with the County
20	Executive and the County Board of Education during the County Budget session
21	in May to ensure the structural deficit in the health care fund is addressed
22	effectively to achieve long-term stability in the fund; and
