The fine of \$4,000 against Defendant Pleitez was suspended pending compliance with the Judgment. Consent Judgments were also entered with Mary Compton and Conley Compton, Jr, under which Defendants are required to remove, within 180 days (if Defendant Pleitez fails to do so), all junk and solid waste, unregistered or inoperable vehicles, and to cease operation of any businesses until such time that a zoning certificate of use issued. Additionally, within 30 days of the denial of a special exception, Defendant agreed to either appeal to the Board of Appeals or comply with the provisions of the non-conforming use decision. A fine of \$1,000 was suspended pending compliance.
