# NAME OF MATTER: Ables, Michael and Lois

Location: 8018 Fort Smallwood Road, Baltimore, MD 21226

Violation: Contempt – Grading without a permit in the Chesapeake Bay Critical Area Buffer

**DISPOSITION:** The parties entered into a Consent Judgment which requires Defendants to obtain all necessary grading permits and inspections by December 28, 2018. A fine of \$1,000.00 was suspended pending compliance, and service costs of \$53.25 were imposed as judgment.

# NAME OF MATTER: Blakemore, Herbert and Marjorie

- Location: 719 Hammonds Lane, Baltimore, MD 21225
- Violation: Failure to keep exterior property free from rodent harborage and infestation; failure to store usable materials on premises in an orderly manner
- **DISPOSITION:** Defendant abated the violation prior to court and the County entered a *nolle prosequi* for the four citations.

# NAME OF MATTER: Brettschneider, Christian W. (Injunction)

- Location: 43 Pebble Drive, Baltimore, MD 21225
- Violation: Changing the use of an approved non-conforming use without first obtaining an approved change of use (from duplex to multiple dwelling)
- **DISPOSITION:** A Consent Judgment was entered, suspending a fine of \$3,000.00 pending compliance and allowing Defendant 90 days to abate the violation (convert structure back to two apartment units), plus service costs of \$100.00 to be paid.

# NAME OF MATTER: Carroll, George and Parker, Shirley

Location: 5333 Chichester Road, Shady Side, MD 20764 Violation: Contempt – Unsafe garage in the **Chesapeake Bay Critical Area** – no permits

- **DISPOSITION:** (Mr. Carroll was previously removed from the original case.) The parties entered into a Consent Judgment which requires Defendants to either obtain a demolition permit and demolish the unsafe structure by September 28, 2018 or obtain a building permit to construct a 6 foot fence around the unsafe structure and post "no trespassing" signs on the property within 60 days of the Judgment. Defendants were also required to pay the previously imposed fine of \$5,000.00 for contempt of court.

#### NAME OF MATTER: Castro, Isaias and Ortiz, Gustavo

- Location: 2611 Evergreen Road, Odenton, MD 21113
- Violation: Contempt Unauthorized construction of four (4) accessory structures (horse barn w/second story; an enclosed structure with open porch and bar area; a round pavilion, and a footbridge spanning a watercourse) without any building or trade permit(s); and unauthorized grading affecting an area of approximately 50,000 square feet of land and placement of mechanical stabilization also without a grading permit or approved stormwater management plan
- **DISPOSITION:** This case was set in for a review hearing. The hearing was postponed at the request of the Defendant and with consent of the County to allow the Defendant time to respond to comment letters issued by the County regarding the Defendant's building and grading permit applications. A new hearing date has been set for August 2, 2018.

- Violation: Outside storage of unregistered vehicles
- **DISPOSITION:** Defendants abated the violation prior to court and the County entered a *nolle prosequi* for the two citations.

- Violation: Failure to maintain and/or provide documentation of fire extinguishing system test/maintenance
- **DISPOSITION:** This case was set for a review hearing. The hearing was postponed at the request of both parties to give the Defendant time to respond to

comment letters for the pending permit. A new hearing date has been set for July 19, 2018.

- Violation: Grading without a permit; development without an approved stormwater management plan
- **DISPOSITION:** This case was postponed prior to court at the request of the Defendant with the consent of the County to give the Defendant more time to submit his grading permit application.

#### NAME OF MATTER: Edwards, Charles J., Jr.

- Location: 5701 Shady Side Road, Churchton, MD 20733 Violation: Outside storage of junk
- **DISPOSITION:** Defendant failed to appear in court. A Judgment on the Affidavit was entered ordering Defendant to abate the violation at the property within 30 days. A fine of \$500.00 was imposed as judgment, along with \$45.00 in service costs (for a total of \$545.00).

# NAME OF MATTER: Fiber Optic Construction, LLC

Location: 546A Arundel Avenue, Glen Burnie, MD 21061 Violation: Contempt – Grading permit and approved stormwater management plan required for grading in excess of 5,000 sg. ft.

- **DISPOSITION:** The County's Petition for Contempt did not go forward, as service was not valid (it was made on the prior resident agent, not current one). The County will refile its Petition for Contempt.

#### NAME OF MATTER: Fuller, Jeffrey P.

Location: 8060 Maywood Avenue, Pasadena, MD 21122

Violation: Construction of a second story on an accessory structure, two decks with steps on an accessory structure addition, a retaining wall, and a roof structure over a new deck on the main house without the required building permit

- **DISPOSITION:** A hearing was held in this case and the Defendant was found to be in violation of the Anne Arundel County Building Code. The court ordered the Defendant to diligently pursue building permits to abate the violation. A fine of \$625.00 and service costs of \$50.00 were also ordered.

- Violation: Contempt Outside storage of unregistered/untagged vehicles; junk and debris

#### NAME OF MATTER: Kaminski, Bernard, III (EBC - citation pier w/o permit)

- Location: 907 Pulaski Avenue, Glen Burnie, MD 21060
- Violation: Contempt Construction of a pier extension without an approved building permit in the **Chesapeake Bay Critical Area**
- **DISPOSITION:** The Petition for Contempt was dismissed, as the Defendant completed their building permit and passed final inspection.

# NAME OF MATTER: Lowe, Rebecca H.

- Location: 6146 Shady Side Road, Shady Side, MD 20764
- Violation: Outside storage of unregistered vehicles and junk
- **DISPOSITION:** The parties entered into a Consent Judgment in which Defendant agreed to abate the violation on the property by removing or tagging all unregistered vehicles within 30 days. A fine of \$1,000.00 was suspended pending compliance and service costs of \$30.00 were imposed as judgment. The citation (4Z41215381)for junk on the property was abated prior to trial and entered as a *nolle prosequi*.

- Violation: Failure to maintain fence around in-ground swimming pool in good repair
- **DISPOSITION:** Defendant abated the violation prior to court and the County entered a *nolle prosequi* for the citation.

#### NAME OF MATTER: McQuade, Milton, Jr. and Bowman, Patricia A.

- Location: 102 Bon Air Road, Baltimore, MD 21225
- Violation: Outside storage of unregistered/dismantled vehicle
- **DISPOSITION:** Defendants abated the violations prior to trial and the County dismissed the injunction.

- Violation: Grading without a permit and approved sediment and erosion controls; grading in a forest conservation easement; continued grading over a Stop Work Order
- **DISPOSITION:** Defendant Craig Miller failed to appear. A Judgment by Default was granted ordering Craig Miller to pay a fine of \$3,750.00 within 14 days of the Judgment being entered. Additionally, the Judgment allows County inspectors right of entry to the property and Craig Miller is enjoined from any grading or building without a permit. Service costs of \$170.00 were ordered jointly with Jimmy Miller, but the full amount was paid by Jimmy Miller.

- Violation: Contempt Outside storage of unregistered vehicles
- **DISPOSITION:** It appears that Thompson Miller, Sr. was the owner of the property at the time the citation was issued against Thompson Miller, Jr. (leading to the underlying Order of which Jr. is in contempt). The case was postponed at the request of both parties so that the County can prepare an Answer to Defendant's Motion to Strike Judgment. Defendant informally agreed to abate the violations which would render the issues in this case as moot. A new hearing date has not yet been set.
