Violation: Construction of addition and shed without the required building permit

**DISPOSITION:** A Consent Judgment was entered which orders the Defendant to complete all required

permits for the addition on the property. A fine of \$125.00 was ordered and suspended

pending abatement.

Violations: Contempt – (1) Zoning violations: outside storage of unregistered vehicles; junk and debris;

contractor's yard; (2) Building violations: construction of shed, deck, fence (over 6'), gazebo, pavilion and garage without building permits; and (3) Grading violations: grading without a grading permit and adding unauthorized impervious surfaces without approved stormwater

management plans

**DISPOSITION:** Corey Belt was not present, but Zanett Belt appeared. Mrs. Belt stated that they been

relying on their engineer to respond to an April 18, 2016 Comment Letter from the County, and that she did not know it was not completed. The County informed the Court that this review was in regards to an October 1, 2015 contempt action and asked for the full \$5,000 fine. The Court imposed \$1,000 in fines on each Defendant (for a total of \$2,000) and suspended the balance. A review hearing has been set for

September 29, 2016.

\$3,000 imposed. Defendant to remove junk and solid waste and unregistered vehicles within 30 days. If Defendant fails to do so, County is authorized to enter property to do

so at Defendant's expense.

signed a modified order which requires a \$100 daily fine and compliance by September 28, 2016. Subsequently, Defendants sent a letter to Judge Ahalt requesting a new hearing. No ruling has been made regarding this request to date.

service costs of \$23.75 (for a total of \$773.75), and to abate the violation by

September 5, 2016.

If Defendants fail to do so, the illegal renovations are to be removed. Fine of \$3,000 against each Defendant suspended pending compliance with the Judgment. Service costs of \$25 for each Defendant were reduced to Judgment against each Defendant.
