# NAME OF MATTER: Alvis, Charles and David (Deed is David and Christine)

- Location: 7810 Renshaw Road, Pasadena, MD 21122 (Lot 17)
- Violation: Outside storage of unregistered vehicles
- **DISPOSITION:** The Defendants failed to appear and a Judgment was entered in favor of the County. The Judgment is for \$1,035.50 jointly and severally. The Defendants have thirty (30) days to abate the violation on the subject property.

- **DISPOSITION:** Review hearing occurred; the County advised the Court that only about 5% progress has been made and that deadline is September 30, 2016. Defendant has failed to hire a contractor to remove items from the property as required in the previous Consent Judgments. A review hearing was set for October 6, 2016.

Location: 907 Pulaski Avenue, Glen Burnie, MD 21060

Violation: Construction of a pier extension without an approved building permit in the **Chesapeake Bay Critical Area** 

- **DISPOSITION:** This matter was postponed until January of 2017. The Administrative Hearing Officer denied Defendant's variance request and he has filed an appeal with the Board of Appeals. This matter is being postponed until the conclusion of the appeal matter.

#### NAME OF MATTER: Kaminski, III, Bernard (Circuit Court 02-C-07-121475 DN)

- Location: 907 Pulaski Avenue, Glen Burnie, MD 21060
- Violation: Contempt Unauthorized grading and clearing in the Chesapeake Bay Critical Area
- **DISPOSITION:** A Consent Judgment was signed by the parties in Court. The Defendant has until November 2, 2016, to obtain an issued grading permit or demolition permit. Upon obtaining the permit, Defendant must complete the plantings by February 1, 2017. Failure to obtain the necessary permits and complete execution of work as stated therein shall result in the County notifying Defendant that it will complete all necessary work. Any costs associated with the work done by the County shall be at the Defendant's expense.

#### NAME OF MATTER: Kaminski, Bernard, III (Building Citation)

- Location: 907 Pulaski Avenue, Glen Burnie, MD 21060
- Violation: Contempt Construction of a second level deck and steps without a building permit, nor a certificate of occupancy, in the **Chesapeake Bay Critical Area**
- **DISPOSITION:** The Defendant failed to appear at Court. A Judgment was entered in favor of the County seeking an additional \$5,000 fine. The Defendant has sixty (60) days to abate the violations before a daily fine of \$200 per day begins to accrue. Currently, the Defendant has numerous violations on the property and cannot obtain permits for the deck until the other violations have been addressed. However, the deck as currently built does not meet County Code regulations.

- **DISPOSITION:** Petition for Contempt was dismissed and the underlying Judgment to remain in place. A lien of \$4,000 Judgment is to be filed in the County's lien index, and the prior Order to be filed in the County's Land Records.

- Violation: Operating a "rooming house" and/or bed and breakfast without a Certificate of Use

All future use to be as allowed in an R2 zone and property shall comply with all changes in the zoning code in the future. County to give Defendant notice of any alleged violations of Order and parties shall make a good faith effort to resolve any dispute.

- **DISPOSITION:** Review hearing held to report on Defendant's compliance with June Order requiring abatement by December 2016. Reported to the Court that Defendants have made little progress towards compliance. Next review hearing is scheduled for November 3, 2016.

- **DISPOSITION:** Delmus Rice appeared and entered into a Consent Judgment whereby he agreed to abate the violation within ninety (90) days. Additionally, a \$125.00 fine and \$45.00 in costs (for a total of \$170.00) were ordered. Nylona Rice failed to appear. A Default Judgment was entered whereby she is to abate the violation within ninety (90) days. A \$125.00 fine and \$20.00 in costs (for a total of \$145.00) were ordered (for a combined total of \$315.00).

- Violation: Grading over 5,000 square feet without an approved grading permit and stormwater management plan
- **DISPOSITION:** All parties entered into a Consent Judgment whereby Defendants agreed to diligently pursue and complete all required permits and approvals. A \$1,500.00 fine was Ordered against each Defendant, but suspended pending compliance. Costs of \$32.50 were ordered against each Defendant (for a total of \$65.00).

- Violation: Contempt Construction of garage with living area without required building permit
- **DISPOSITION:** Defendants failed to appear. A Fifth Judgment of Constructive Civil Contempt was entered. A fine of \$3,000 against each Defendant was entered (for a total of \$6,000). Defendants ordered to revise building permit B02230688 within fifteen (15) days and to complete the permit within sixty (60) days. If Defendants fail to do so, the County is authorized to enter the property and abate the violation at Defendants' expense.
