
The Planning Advisory Board (PAB) is a citizen advisory board created by §532 of the Anne Arundel County Charter. Under § 533 of the Charter, the PAB is charged with recommending the list of capital projects, along with their estimated costs, to be implemented by the County. Also under § 533, the PAB considers and transmits advisory recommendations for amendments to the Capital Budget to the County Executive through the course of the year.

The PAB met on September 14, 2022 and received an overview of Bill 78-22 from the Office of Budget, Anne Arundel Community College, and Central Services staff. This Ordinance is for the purpose of amending the Capital Budget for Fiscal Year 2023 by making a supplementary appropriation of \$937,500 from Maryland Higher Education Commission State Funding to the Anne Arundel Community College State Funded Systemics Program (J540700) and amending the scope and description of the Woodland Beach Volunteer Fire Station Relocation (F573000).

Following the presentation and discussion among the members of the PAB, the Board voted 7-0 to offer an advisory recommendation of approval of Bill 78-22.
