1 RESOLUTION approving the submission of a name for the Property Tax Assessment
2 Appeal Board

4 WHEREAS, § 3-102 of the Tax-Property Article of the Annotated Code of
5 Maryland provides that there shall be a Property Tax Assessment Appeal Board in
6 Anne Arundel County; and

8 WHEREAS, § 3-103 of the Tax-Property Article of the Annotated Code of
9 Maryland provides that the Board members shall be appointed by the Governor
10 from a list of qualified applicants submitted by the County Executive with the
11 approval of the County Council; and

13 WHEREAS, the Board consists of three regular members and three alternate
14 members, each serving a term of 5 years beginning on June 1 of the year of
15 appointment; and

16
17 WHEREAS, a vacancy will exist on June 1, 2023, when the term of Chaim Starkey,
18 an alternate member, will expire; and

20 WHEREAS, § 3-103 of the Tax-Property Article provides that a list of three names
21 for each vacancy shall be submitted to the Governor; and

22
23 WHEREAS, there has not been sufficient interest in the upcoming vacant position
24 to result in the submission of three names for the vacancy; and

26 WHEREAS, the County Executive, subject to the approval of the County Council,
27 has submitted Chaim Starkey, incumbent, to fill the vacancy for an alternate
28 member; now, therefore, be it

30 *Resolved by the County Council of Anne Arundel County, Maryland,* That it hereby
31 approves the submittal of Chaim Starkey, incumbent, to the Governor as a qualified
32 applicant to be an alternate member of the Property Tax Assessment Appeal Board to serve
33 the term ending June 1, 2028; and be it further
