BWI Community Development Foundation, Inc Shuttle	\$ 659,000.00	\$ (50,000.00)	\$ 623.99	BWI continued to operate the County Connector Shuttle, connecting residents, workforce, and job- seekers to recreation and employment opportunities in and around Live! Casino & Hotel, Arundel Mills Mall, BWI Marshall Airport, and the BWI MARC/Amtrak Station. This transit service is fare-free and operates 365 days a year, weather permitting. This year, BWI added a stop to accommodate Amazon employees and, even during a pandemic, provided nearly 60,000 rides. <i>Note: \$50,000 in unspent funds was used to supplement their FY22 award in order to account for</i> <i>increased vendor costs.</i>		
Christian Assistance Program	\$ 20,000.00		\$ -	Funds were used to continue CAP's Weis Market voucher program, which provides store vouchers to residents of the target area to purchase fresh milk, and dairy case items once per month to complement the non perishable foods provided at the CAP pantry. LDC grant funding allowed CAP to expand the nutritious foods noted above to include fresh and frozen fruits and vegetables, and increase the amount of the voucher from \$8 per household to up to \$25, depending upon household size. Between their pantry and the voucher program, CAP served approximately 1,500 unique individuals across 400 households during the fiscal year.

During FY 2021, Provinces procured a design engineer, Bayland Consultants and Designers, Inc. to design a capital project that will retrofit the existing storm water management pond and it's outfall channel. The design is approximately 90% completed and has been submitted for local, State and federal permits. Once the project goes to construction, it will include modifications to the existing pond to allow for more storage, reconstructing the embankments to meet current regulations, and replacing the current outfall with a regenerative step pool storm conveyance system (SPSC). The proposed design will be eligible to receive additional impervious acre and pollutant removal credits. The proposed design is estimated to cost \$3,890,218 to implement and the project sponsor is working with Maryland DNR and County DPW to secure capital funds to implement the project and will most likely seek additional LDC funds for construction.
