I just wanted to share and pass on my experience with my ride-along in Anne Arundel on 1/30/23.

I believe I rode with Lt. Clopein [I could be wrong]. Riding with AACO, and especially the EMS1 Lieutenant was extremely helpful and beneficial. He immediately welcomed me and showed me the supervisor's car.

During the shift, he asked me if there was anything I'd like to work on and started to challenge me on knowledge and protocols. He also spent a great deal of time with me going over procedures and medications. He went into depth and great detail about pharmacology and then physiology; explaining the why vs the how for various topics. I found this vital and appreciative of how above and beyond he went in his teaching.

During the end of the ride-along, we were dispatched for a cardiac arrest. He immediately announced to everyone who I was and that I was with MSP. The LT and the crew got me involved. The LT would also pull me aside and show me the Ultrasound during rhythm checks to teach me about how they incorporate the procedure into the code since I did not have any experience with US.

This ride-along was extremely valuable and a great refresher for me, especially after being away from the field since the start of the academy. It was interesting to learn and see in first person how advanced this county was with their procedures and protocols.
