Dear Mr. Donahue:

The Fiscal Year 2025 (FY25) Public School Construction Capital Improvement Program (PSC CIP) request, as submitted to the Interagency Commission on School Construction (IAC) by the Anne Arundel County Local Education Authority (AAC LEA), has been received and reviewed by County Government.

In accordance with procedures set forth by the IAC, written local government support for the PSC CIP request and any subsequent amendments to that request is required by 11/30/23. I support the FY25 PSC CIP request to be submitted to the IAC by the AAC LEA, and urge your recommendation of State funding for all FY25 requests presented therein.

As you are aware, the Board of Education's official request for FY25 local funding will not be submitted to the County until March of 2024. The County Charter requires a budget process that provides final approval in June of 2024. It should be noted, that despite the fact that State aid amounts to approximately one-third of the total approved CIP, I am aware of no instances where the County has not supported a Board of Education project that has been approved for funding by the State.

The general guidelines outlined in section 102.1.A.1.a. and b. of the PSC CIP procedures manual are well stated. Accordingly, County support for the FY25 PSC CIP request submitted by the AAC LEA is similarly prioritized in light of the "anticipated availability of both local and State funds" and the recognition that "local capital needs for school construction projects far exceed both local and State resources."

The priority requests submitted by the AAC LEA, accounting for \$78.6 million (the entire PSC CIP request for FY25), have already been <u>fully</u> supported by prior approved (FY24 and prior) appropriation authority provided by the County to the Anne Arundel County Board of Education. In other words, County funding has already been made available to the County Board of Education to spend on these projects. These requests should take precedence over any remaining requests.

As a general rule, the County supports the relative priorities assigned by the AAC LEA and a listing of the entire PSC CIP request for FY25 is attached.

I appreciate your continued support of our efforts to deliver quality public education to the more than 83,000 public school students in Anne Arundel County.
