1 RESOLUTION approving a conditional appropriation of Coronavirus State and Local  
2 Fiscal Recovery Funds in excess of \$500,000 to the Grants Special Revenue Fund

4 WHEREAS, § 4-11-114(c) of the County Code, as amended by Bill Nos. 111-21  
5 and 112-21, allows appropriation of revenue from a grant included in an  
6 appropriation ordinance but in excess of the amount anticipated for the grant, as  
7 well as any County matching funds, to the Grants Special Revenue Fund if certain  
8 conditions are met; and

10 WHEREAS, appropriations under § 4-11-114(d) , as amended by Bill Nos. 111-21  
11 and 112-21, that are in excess of \$500,000 and are funded by Coronavirus State and  
12 Local Fiscal Recovery Funds distributed by the United States Treasury must be  
13 presented to the County Council by Resolution, and three or more members of the  
14 Council may request a hearing to act on the Resolution, such hearing to be held not  
15 more than ten business days from the date of receipt of the Resolution; and

17 WHEREAS, the failure of three or more members of the Council to request a  
18 hearing on the Resolution within two business days constitutes approval of the  
19 conditional appropriation; and

21 WHEREAS, by this Resolution, the County Executive is requesting appropriation  
22 of Coronavirus State and Local Fiscal Recovery Funds distributed by the United  
23 States Treasury in the amount of \$2,127,889 to the Health Department, Grants,  
24 Contributions and Other; now, therefore, be it

26 *Resolved by the County Council of Anne Arundel County, Maryland, That, the*  
27 *provisions of § 4-11-114(c) and (d) of the County Code, as amended by Bill Nos. 111-21*  
28 *and 112-21, having been met, the County Council approves the appropriation of*  
29 *Coronavirus State and Local Fiscal Recovery Funds distributed by the United States*  
30 *Treasury in the amount of \$2,127,889 to the Health Department, Grants, Contributions and*  
31 *Other.*
