#### **Gambrills Area Map**











### **Trail Overview**

- Development occurs entirely within County right-of-way
- 1.7 miles from Sappington Station Road to Bonheur Avenue
- 10' wide asphalt surface
- ADA accessible slopes generally 4.5% or less
- Multiple retaining walls and a boardwalk and bridge to minimize tree clearing, grading, and environmental impacts
- Stormwater management facilities and landscaping provided along trail
- Three road crossings proposed: Burns Crossing Road, Gambrills Road, and Holladay Street

- Steep side slopes and wetland areas
- Parking Lot at west end of trail
- Crosswalk and Signal Improvements at Burns
- **Crossing Road**
- Retaining Walls to minimize clearing
- Boardwalk to access Watts Avenue and Arundel High School




## **Gambrills Road to Holladay Street**
