

# **Project Background – Existing Park Location**





## **Project Background**

- 1976 Anne Arundel County purchased the property for public recreation & open space.
- 1980's Some existing structures were renovated, and the new Bathhouse was constructed.
- 1980 DRP Day Camp Program moved to the Park and in the ensuing 42 years, over 18,000 campers of all abilities have benefitted from the park setting and the programs provided by dedicated DRP staff & volunteer counselors.
- The existing 5,125 SF Day Camp & Operations Building has been renovated & repaired many times over the years.
- 2021 Mayo Beach Park Facility Assessment identified the lack of a dedicated space for the Summer Day Camp program and recommended that a Replacement Building be provided.
- 2022 Design of a Replacement Building begins.



# The DRP Day Camp Program at Mayo Beach Park

- The DRP Day Camp Program provides a structured environment that helps transition our campers back into the school year, or depending on age, transition into the workforce.
- Arts & Crafts, Beach Swim, Fishing, Kayaking & Canoeing, Music & Theater and Sports
- With a full-time Registered Nurse on staff and a staff to camper ratio of 3:1, parents are very comfortable enrolling their children in the Day Camp Programs year after year.
- The Day Camp also hosts the annual "Volunteer Summer Serve" program which provides our youth volunteers valuable experience working with children of all abilities.
- The Day Camp Program is offered for 7 weeks typically starting in late June and running though mid August, from 9:00 AM – 3:00PM Monday thru Friday. Approximately 75 campers attend each week.
- A Replacement Building designed around our Day Camp Program would create additional opportunities for our children with disabilities to work on their social, cognitive and motor skills in a safe and nurturing environment.



## **Replacement Building Program**

- The proposed 4,775 SF Replacement Building is <u>350 SF smaller and sits entirely within the footprint of the existing building it replaces.</u>
- The proposed Replacement Building includes:

Interior Enclosed Spaces:

Day Camp Uses 1,920 SF Park Operations Uses 1,180 SF Table & Chair Storage Use 325 SF

Covered Outdoor Space & Walkways 1,350 SF
Total Footprint: 4,775 SF
