Central Recycling Center Used Oil & Antifreeze Recycling

The first phase of upgrades to the Central Recycling Center's (CRC) Meet & Greet area and Used Oil & Antifreeze Drop-off area (Oil Shed) are complete.

This phase includes a new storage area, epoxy floor coating, as well as lighting and electrical services to the Oil Shed; renovations to the Meet & Greet building (windows, ventilation, HVAC, doors, roof, and a new roof on the customer canopy with associated lighting); an enhanced stormwater management bioretention feature, and traffic safety bollards around the two buildings.

These enhancements will provide continued services to the residents of Anne Arundel County well into the future, and a continuation of our environmental stewardship with liquid waste recycling.

The facility reopened for normal operations on Monday, July 24, 2023.



U.S. Department of Commerce—SABIT Program Tour

On April 27, DPW's Bureau of Waste Management Services hosted a tour of its integrated waste management system at the Millersville Landfill and Resource Recovery Facility campus in Severn.

The tour was sponsored by the U.S. Department of Commerce, under its Special American Business Internship Training (SABIT) Program, a business leader exchange program. Through this two-week, industry-specific program, business leaders from Eurasia, South Asia, and Europe are able to learn best practices used in the United States by meeting with public and private sector officials and professional associations and touring facilities.

A group of 18 participants from Ukraine, Moldova, Georgia, Azerbaijan, Uzbekistan, Turkmenistan, Kyrgyzstan, and Kazakhstan joined DPW for a talk and facility tour. The delegates consisted of a mix of solid waste managers and business leaders from their representative countries.

Anne Arundel County Residents ONLY. Commercial Vehicles and Commercial Waste NOT ACCEPTED

During each event, trained personnel will ask you to remain in your car while they unload the HHW from your trunk. To make unloading safe for staff and fast for you:

- Tightly secure all container lids to avoid leaks and spills, then set your HHW in plastic totes or boxes to contain accidental spills during transport.
- Call 410-222-7951 before an event if you have any drums of material.
- Transfer large amounts of fuel into travel-safe gas cans so staff can empty them and return them back to the owner for reuse.
- Keep materials in their original packaging, when possible, and label anything that had to be packed in alternative containers. Never mix different types of HHW in one container.
- Secure material in your vehicle's trunk, backseat or truck bed, to keep it safely away from ٠ passengers during transport.
- Make sure items can be easily accessed. Never cover or block your materials under other items like trash or yard waste.

Anne Arundel County now accepts clean, empty glass food and beverage bottles and jars of any color, shape, or size at all of its recycling centers. Just look for the specially marked recycling dumpster or ask an attendant, then sort the glass into 3 groups jars with lids and labels into their yellow recycling con-(Clear - Brown - Mixed glass (green, blue, yellow, red, etc.).

Choosing this option provides for closed-loop glass recycling because the color-separated glass will be marketed for use in the manufacturing of new glass.

- Must be CLEAN Lids & Labels OKAY
- NO Food or Liquids Sort by Color Clear/
 - Brown/All Other Colors

Note: Customers may continue to place glass bottles and tainers or in the single-stream dumpster at any Recycling Center.
