A BILL ENTITLED

1 AN ORDINANCE concerning: Current Expense Budget – Capital Budget and Program –
2 Supplementary Appropriations

4 FOR the purpose of making supplementary appropriations from contingent funds in the
5 general fund of the County for the current fiscal year; amending the Capital Budget for
6 the current fiscal year by modifying a funding source in the Brooklyn Park Outdoor
7 Rec Imps capital project; amending the Capital Program for the current fiscal year; and
8 generally relating to making supplementary appropriations to the Current Expense
9 Fund and amending the Capital Budget and Program for the fiscal year ending June 30,
10 2024.

16 WHEREAS, under Section 712 of the Charter, upon the recommendation of the
17 County Executive, the County Council may make supplementary and emergency
18 appropriations from contingent funds, provided that the Controller shall first certify
19 in writing that such funds are available for appropriation; and

21 WHEREAS, the County Executive has recommended a supplementary
22 appropriation of contingent funds to the Office of Finance, Non-Departmental, in
23 the Current Expense Budget, and the Controller has certified in writing that such
24 funds are available for appropriation; and

26 WHEREAS, the Brooklyn Park Outdoor Rec Imps capital project (Project No.
27 P576500) has an existing appropriation in the Capital Budget for the fiscal year
28 ending June 30, 2024; and

WHEREAS, Section 716 of the Charter authorizes the County Council, upon request of the County Executive and by affirmative vote of five members of the County Council, to amend the Capital Budget; and

WHEREAS, the County Executive has recommended amending the Capital Budget by modifying a funding source in the Brooklyn Park Outdoor Rec Imps capital project, Project No. P576500; and

WHEREAS, in accordance with Section 716 of the Charter, the Planning Advisory Board has recommended this amendment to the Capital Budget; now, therefore,

SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,* That the Current Expense Budget for the fiscal year ending June 30, 2024, is hereby amended by making a supplementary appropriation from contingent funds as follows:

Chief Administrative Office – General Fund Appropriation	
Contingency	
Grants, Contributions & Other	\$ 1,000,000

and by adding such funds to the below-listed department in the amount set forth:

Office of Finance (Non-Departmental)	
Pay-As-You-Go	
Grants, Contributions & Other	\$ 1,000,000

SECTION 2. *And be it further enacted,* That the Capital Budget for the fiscal year ending June 30, 2024, is hereby amended by modifying a funding source from:

Brooklyn Park Outdoor Rec Imps (Project No. P576500)	
(Miscellaneous)	\$ 1,000,000

to:

Brooklyn Park Outdoor Rec Imps (Project No. P576500)	
(General Fund PayGo)	\$ 1,000,000

SECTION 3. *And be it further enacted,* that the Capital Program for the fiscal year ending June 30, 2024, is hereby amended in accordance with the provisions of this Ordinance.


SECTION 4. *And be it further enacted,* That this Ordinance shall take effect from the date it becomes law.
