A BILL ENTITLED

1 AN ORDINANCE concerning: Board of Appeals – Compensation – Per Diem Allowance
2
3 FOR the purpose of increasing a per diem allowance for members of the Board of Appeals;
4 applying this Ordinance retroactively; and generally relating to boards, commissions,
5 and similar bodies.

7 BY repealing and reenacting (with amendments): § 3-1-102(b)
8 Anne Arundel County Code (2005, as amended)

10 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*
11 That Section(s) of the Anne Arundel County Code (2005, as amended) read as follows:

13 ARTICLE 3. BOARDS, COMMISSIONS, AND SIMILAR BODIES

14 TITLE 1. BOARD OF APPEALS

15 16 17 **3-1-102. Compensation.**

19 (a) **Generally.** Each member of the Board of Appeals is entitled to an annual salary of
20 \$5,250.
21

22 (b) **Per diem allowance.** In addition to the salary provided in subsection (a), each
23 member is entitled to a per diem allowance of ~~[\$75]~~ \$125 for each day on which the
24 member incurs necessary travel and incidental expenses while engaged in the discharge of
25 official duties. The allowance is subject to the approval of the Chairman and Vice
26 Chairman of the Board of Appeals on a form prepared by the Clerk to the Board of Appeals.

1 SECTION 2. *And be it further enacted*, That this Ordinance shall be construed to apply
2 retroactively and shall be applied to an application for a per diem allowance filed by a current
3 member of the Board of Appeals on or after January 1, 2024.

5 SECTION 3. *And be it further enacted*, That this Ordinance shall take effect 45 days
6 from the date it becomes law.
