## A BILL ENTITLED

1	AN ORDINANCE concerning: Comprehensive Zoning – Region 2
2	
3	FOR the purpose of repealing certain comprehensive zoning maps for Region Planning
4	Area No. 2; adopting the Anne Arundel County Digital Zoning Layer for Region
5	Planning Area No. 2, as amended by this Ordinance, covering Annapolis Junction, Fort
6	Meade, Hanover, Jessup, Laurel, and Maryland City; and generally relating to
7	comprehensive zoning.
8	
9	WHEREAS, by Bill No. 11-21 the County Council adopted "Plan2040", the
10	County's General Development Plan, which included land use recommendations,
11	required to be further refined by region plans, that may be implemented through
12	comprehensive zoning; and
13	
14	WHEREAS, Bill No. 11-21 amended, among other things, § 18-2-103 of the Anne
15	Arundel County Code (2005, as amended), and required that the County be divided
16	into no less than seven region areas encompassing all unincorporated areas of the
17	County; and

WHEREAS, Bill No. 11-21 and Plan2040 created, adopted, and depicted the 1 boundaries of nine region planning areas, including the Region 2 Planning Area; 2 3 and 4 WHEREAS, Bill No. 11-21 and Plan2040 provided for the creation of region plans 5 6 for each region planning area and the creation of stakeholder advisory committees for each region planning area; and 7 8 9 WHEREAS, § 18-2-103(e)(4), as adopted by Bill No. 11-21, requires that each region plan shall include maps depicting any changes to the land use map included 10 in Plan2040, and a description of how the changes are consistent with the goals and 11 12 policies of Plan2040; and 13 WHEREAS, the Office of Planning and Zoning, after consideration of the 14 recommendations of the Stakeholder Advisory Committee for Region Planning 15 Area No. 2 and the Planning Advisory Board, prepared the "Anne Arundel County 16 Region 2 Plan" dated January 26, 2024; and 17 18 WHEREAS, contemporaneous with the introduction of this Ordinance, 19 20 Bill No. 6-24 was introduced to this Council, and proposes the adoption of the 21 "Anne Arundel County Region 2 Plan", the region plan for Region Planning Area 22 No. 2; and 23 24 WHEREAS, this Bill proposes comprehensive zoning consistent with Plan2040, as amended by the "Anne Arundel County Region 2 Plan", the region plan for Region 25 Planning Area No. 2, as adopted by Bill No. 6-24; now, therefore 26 27 SECTION 1. Be it enacted by the County Council of Anne Arundel County, Maryland, 28 That the portions of the Digital Zoning Layer dated February 22, 2011, for the Region 29 Planning Area No. 2, adopted in whole or in part by Bill No. 12-11, as amended, are hereby 30 31 repealed. 32 SECTION 2. And be it further enacted, That the Anne Arundel County Digital Zoning 33 Layer, dated January 26, 2024, for Region Planning Area No. 2 of Anne Arundel County 34 is hereby amended as follows: 35 36 1. In the Anne Arundel County Digital Zoning Layer, change the zoning on the property 37 known as Parcel 49 on Tax Map 13, Tax Account Number 04-000-00315708, from C2 to 38 MXD-E, as shown in the cross-hatched areas on Exhibit A. 39 40 (Amendment No. 1) 41 2. In the Anne Arundel County Digital Zoning Layer, change the zoning on a portion 42 of the properties known as Parcels 88 and 200 on Tax Map 19, Tax Account Numbers 43 04-000-00082000 and 04-000-00080315, from OS to C4, as shown in the cross-hatched 44 areas on Exhibit B. 45 (Amendment No. 2) 46

1	3. In the Anne Arundel County Digital Zoning Layer, change the zoning on a portion
2	of the property known as Parcel 86, Lot 1 on Tax Map 19, Tax Account Number
3	04-000-03593300, from OS to W1, as shown in the cross-hatched areas on Exhibit D.

7	4. In the Anne Arundel County Digital Zoning Layer, change the zoning on the property
8	known as Parcels 86, 108, 166, 383, 467, and 543 on Tax Map 14, Tax Account Number
9	<u>4-000-90079934</u> , 4-000-90079935, 4-000-90079936, 4-000-90004448, 4-000-90079937,
10	<u>4-000-06583700, 4-000-06584900, 4-000-06583520, 4-000-03765600, 4-000-03764000,</u>
11	and 4-000-04546080, from R5 - Residential to R - Residential as shown in the
12	cross-hatched areas on Exhibit E.

15	5. In the Anne Arundel County Digital Zoning Layer, change the zoning on an
16	approximately 52-acre portion of the property known as Parcel 372 on Tax Map 29, Tax
17	Account Number 4-000-90231589, from R1 to C2, as shown in the cross-hatched areas on
18	Exhibit F.

21	6. In the Anne Arundel County Digital Zoning Layer, change the zoning on a portion
22	of the properties known as part of Lots 13 and 14, Parcel 219 on Tax Map 7, Tax Account
23	Number 4-444-02879753, from R1 to OS, as shown in the cross-hatched areas on
24	Exhibit G.
25	(Amendment No. 7)

27	7. In the Anne Arundel County Digital Zoning Layer, change the zoning on a portion
28	of the property known as Parcel 179 on Tax Map 7, Tax Account Number 4-444-01229353,
29	from R1 to OS, as shown in the cross-hatched areas on Exhibit H.

33	8. In the Anne Arundel County Digital Zoning Layer, change the zoning on a portion
34	of the property known as Parcel 277 on Tax Map 7, Tax Account Number
35	04-444-06323550, from R1 to OS, as shown in the cross-hatched areas on Exhibit J.

39	9. In the Anne Arundel County Digital Zoning Layer, change the zoning on the property
40	known as part of Lots 12 and 39, Parcel 265 on Tax Map 13, Tax Account Number

4	<u>4-150-02437420</u> , <u>4-150-90037679</u> , <u>4-150-00411600</u> , <u>4-150-00539070</u> , and
5	4-150-02588380, from C1 – Local Commercial to SB – Small Business as shown in the
6	cross-hatched areas on Exhibit M.

13	4-473-90010185, 4-473-90010186, and 4-473-90010187, from R5 - Residential
14	to R1 - Residential as shown in the cross-hatched areas on Exhibit N.

21	90095020, 4-000-90095021, 4-000-90095022, 4-000-90095023, and 4-000-90095025,
22	from R5 - Residential to R1 - Residential as shown in the cross-hatched areas on Exhibit O.

26	SECTION 2. 3. And be it further enacted, That the Anne Arundel County Digital
27	Zoning Layer dated January 26, 2024, for Region Planning Area No. 2 of Anne Arundel
28	County, as amended by this Ordinance, prepared by the Office of Planning and Zoning, is
29	hereby approved and adopted.
30	
31	SECTION 3. 4. And be it further enacted, That the Anne Arundel County Digital
32	Zoning Layer dated January 26, 2024, for Region Planning Area No. 2, as amended by this
33	<u>Ordinance</u> , that is described in Section $2 3$ of this Ordinance is incorporated by reference
34	as if fully set forth and a certified copy shall be permanently kept on file in the office of
35	the Administrative Officer to the County Council and in the Office of Planning and Zoning.
36	
37	SECTION 4. 5. And be it further enacted, That this Ordinance shall take effect 45 days
38	from the date it becomes law.
