### A BILL ENTITLED

1 AN ORDINANCE concerning: Public Works – Solid Waste Collection – Solid Waste  
2 Service Charge – Solid Waste Landfill and Facility Delivery Fees

3  
4 FOR the purpose of modifying the solid waste service charge; modifying certain charges  
5 for delivery of solid waste to a landfill or waste disposal facility; providing for the  
6 effective date of this Ordinance; and generally relating to the solid waste service  
7 charge.

9 BY repealing and reenacting, with amendments: § 13-4-105(b); and 13-4-107(d) and (e)  
10 Anne Arundel County Code (2005, as amended)

12 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*  
13 That Section(s) of the Anne Arundel County Code (2005, as amended) read as follows:

#### 18 19 **13-4-105. Solid waste service charge.**

21 (b) **Amount.** There is a service charge in the amount of ~~[[ \$380 ]]~~ \$404 per fiscal year.  
22 For the fiscal year beginning July 1, ~~[[ 2024 ]]~~ 2025, and for each fiscal year thereafter, the  
23 County Executive shall set the service charge for County curbside collection service and

1 may increase the charge in an amount not to exceed 5.00% of the then current charge. Any  
2 increase greater than 5.00% shall be set by the County Council by ordinance. The service  
3 charge shall be collected as provided in § 1-8-101 of this Code.

4 **13-4-107. County owned or operated landfills and solid waste disposal facilities.**

6 (d) **Charges.** Each person delivering solid waste shall pay the charges set forth in the  
7 chart in this subsection:

Solid waste delivered by a commercial business	[[ <del>\$85</del> ]] \$100 per ton
Solid waste delivered in a dump truck, flatbed truck, stake body truck, box truck, rental truck/trailer, or double axle trailer	[[ <del>\$85</del> ]] \$100 per ton

10 (e) **Charges based on weight.** All charges based on weight shall be computed  
11 proportionally, with a 60-pound minimum. When a weighing scale is unavailable or  
12 inoperative and the solid waste is delivered in an open vehicle, the Department shall  
13 estimate the weight of the solid waste and the charge is [[~~\$85~~]] \$100 per ton in accordance  
14 with the estimate. When a weighing scale is unavailable or inoperative and the solid waste  
15 is delivered in a closed vehicle, the charge is [[~~\$37.50~~]] \$44.20 per cubic yard of rated  
16 capacity.

18 SECTION 2. *And be it further enacted,* That this Ordinance shall take effect on  
19 July 1, 2024.
