A BILL ENTITLED

1 AN ORDINANCE concerning: Anne Arundel County Transit Development Plan 2024

3 FOR the purpose of adopting the “Anne Arundel County Transit Development Plan 2024”;
4 and generally relating to the “Anne Arundel County Transit Development Plan 2024”.

6 SECTION 1. *Be it enacted by the County Council of Anne Arundel County,*
7 *Maryland,* That, after passage of this Ordinance, the Director of the Office of
8 Transportation shall amend text maps, charts, graphs, photos, and tables in the “Anne
9 Arundel County Transit Development Plan 2024”, in accordance with any amendments to
10 this Ordinance.

12 SECTION 2. *And be it further enacted,* That, after passage of this Ordinance, the
13 Director of the Office of Transportation may correct obvious errors, capitalization,
14 spelling, grammar, headings, and similar non-substantive matters and may publish the
15 “Anne Arundel County Transit Development Plan 2024”, and may add or amend covers,
16 title pages, pagination, a table of contents, and graphics to improve readability.

18 SECTION 3. *And be it further enacted,* That the “Anne Arundel County Transit
19 Development Plan 2024” is incorporated herein by reference as if fully set forth, and shall
20 replace any earlier versions of the Anne Arundel County Transit Development Plan. A
21 copy of the “Anne Arundel County Transit Development Plan 2024” shall be permanently
22 kept on file with the Administrative Officer of the County Council, the Office of
23 Transportation, the Office of Planning and Zoning, and the Department of Public Works.

25 SECTION 4. *And be it further enacted,* That this Ordinance shall take effect 45 days
26 from the date it becomes law.
