A BILL ENTITLED

1 AN ORDINANCE concerning: Current Expense Budget – Supplementary Appropriation
2 – Severn Grove Special Community Benefit District
3

4 FOR the purpose of providing an appropriation of funds from unanticipated revenues for
5 the Severn Grove Special Community Benefit District for the current fiscal year; and
6 generally relating to making supplementary appropriations of funds to the current
7 expense budget for the fiscal year ending June 30, 2025.

9 BY amending: Current Expense Budget
10

11 WHEREAS, under Section 712 of the Charter, upon the recommendation of the
12 County Executive, the County Council may make supplementary appropriations
13 from revenues received from anticipated sources but in excess of budget estimates
14 and from revenues received from sources not anticipated in the budget for the
15 current fiscal year, provided that the Controller shall first certify in writing that such
16 funds are available for appropriation; and

18 WHEREAS, the County Executive has recommended a supplementary
19 appropriation of community held fund balance for the Severn Grove Special
20 Community Benefit District in the amount of \$24,011.33, and the Controller has
21 certified in writing that such funds are available for appropriation; now, therefore,

23 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*
24 *That the Current Expense Budget for the fiscal year ending June 30, 2025, is hereby*
25 *amended by making supplementary appropriations from revenues received from sources*
26 *not anticipated in the budget to the Severn Grove Special Community Benefit District in*
27 *the amount of \$24,011.33.*

1 SECTION 2. *And be it further enacted*, That this Ordinance shall take effect from the
2 date it becomes law.
