A BILL ENTITLED

1 AN ORDINANCE concerning: Capital Budget and Program – Roads and Bridges, Traffic
2 Control, Board of Education, and Recreation and Parks capital projects –
3 Supplementary and Transfer of Appropriations
4

5 FOR the purpose of amending the Capital Budget for the current fiscal year by making a
6 transfer of appropriations within certain Recreation and Parks, and Roads and Bridges
7 capital projects; amending the Capital Budget for the current fiscal year by making
8 supplementary appropriation of funds to certain Traffic Control and Board of Education
9 capital projects; amending the Capital Program and Capital Projects Bond Ordinance
10 for the current fiscal year; and generally relating to appropriations of funds in projects
11 in the Capital Budget for the fiscal year ending June 30, 2025.

17 WHEREAS, Section 716 of the Charter authorizes the County Council, upon
18 request of the County Executive and by affirmative vote of five members of the
19 County Council, to amend the Capital Budget; and

21 WHEREAS, pursuant to Sections 712 and 716 of the Charter, upon
22 recommendation of the County Executive, the County Council may make
23 supplementary appropriations to the Capital Budget from revenues received from
24 anticipated sources but in excess of budget estimates therefor, or from revenues
25 received from sources not anticipated in the budget for the current fiscal year; and

WHEREAS, the County Executive is requesting that the WB & A Trail capital project (Project No. P393600) and the Bluewater/Milestone SUPs capital project (Project No. H587300) be amended to modify funding sources for certain appropriated funds; and

WHEREAS, additional funding in the total amount of \$17,450,431 has become available for various Traffic Control and Board of Education capital projects from grants and a miscellaneous funding source, which are sources anticipated in the budget, but in excess of budget estimates therefor, or are sources not anticipated in the budget for the current fiscal year; and

WHEREAS, the County Executive is requesting that the Capital Budget be amended by making supplementary appropriations from the Other State Grants and Miscellaneous funding sources to various Traffic Control and Board of Education capital projects as set forth herein; and

WHEREAS, in accordance with Section 716 of the Charter, the Planning Advisory Board has recommended these amendments to the Capital Budget; and

WHEREAS, the Controller has certified in writing that the funds are available for appropriation; now, therefore,

SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,* That the Capital Budget for the fiscal year ending June 30, 2025, is hereby amended by transferring appropriations in the amount of \$560,000 in the WB & A Trail capital project (Project No. P393600) from the General County Bonds funding source to the Other State Grants funding source.

SECTION 2. *And be it further enacted,* That the Capital Budget for the fiscal year ending June 30, 2025, is hereby amended by transferring appropriations in the amount of \$849,600 in the Bluewater/Milestone SUPs capital project (Project No. H587300) from the General County Bonds funding source to the Other State Grants funding source.

SECTION 3. *And be it further enacted,* That the Capital Budget for the fiscal year ending June 30, 2025, is hereby amended by making supplementary appropriations to the following capital projects as follows:

11 Projects Bond Ordinance for the fiscal year ending June 30, 2025, are hereby amended in
12 accordance with the provisions of this Ordinance.

15 date it becomes law.
