## A BILL ENTITLED

1	AN ORDINANCE concerning: Branches of County Government - Executive Branch -
2	Reorganization – Office of Transportation – Public Ethics – Transportation Officer

4	FOR the purpose of creating an Office of Transportation; designating the Transportation
5	Officer as the office head, appointed by and serving at the pleasure of the County
6	Executive; providing for the duties of the Office of Transportation; providing for the
7	qualifications of the Transportation Officer; requiring the Transportation Officer to file
8	financial disclosure statements as required under the Ethics Article; providing for the
9	applicability of this Ordinance; and generally relating to the executive branch of
10	County government and public ethics.

They shall possess the qualifications required by the Charter and this Code and be appointed solely on the basis of their qualifications for performing the duties of office.
