4 FOR the purpose of extending the time for the onsite sale of seafood harvested on certain
5 days; and generally relating to zoning.

7 BY repealing and reenacting with amendments: § 18-10-172(10)
8 Anne Arundel County Code (2005, as amended)

10 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*
11 That Section(s) of the Anne Arundel County Code (2005, as amended) read as follows:

12 ARTICLE 18. ZONING

13 TITLE 10. REQUIREMENTS FOR CONDITIONAL USES

14 15 16 17 **18-10-172. Waterman’s home commercial use.**

19 A waterman’s home commercial use shall comply with all of the following
20 requirements.

22 (10) The onsite sale of seafood harvested by a resident is allowed by the resident only
23 during the hours of 9:00 a.m. to 6:00 p.m. Monday through ~~[[Friday]]~~ SATURDAY and 9:00
24 a.m. to 4:00 p.m. ~~[[Saturday and]]~~ Sunday.

1 SECTION 2. *And be it further enacted*, That this Ordinance shall take effect 45 days
