1	AN ORDINANCE concerning: Subdivision and Development - Adequate School
2	Facilities – School Utilization Chart
3	
4	FOR the purpose of approving the "School Utilization Chart 2025" prepared by the
5	Planning and Zoning Officer.

7	WHEREAS, Section 17-5-502(a) of the County Code provides that the Planning
8	and Zoning Officer shall prepare a school utilization chart no later than
9	March 1 each year for the approval by ordinance of the County Council; and

11	WHEREAS, the Planning and Zoning Officer prepared a school utilization chart
12	entitled "School Utilization Chart 2025", based on information supplied by the
13	Board of Education as to State-rated capacity for each public school, actual
14	enrollment for each public school for the 2024-2025 school year as of
15	November 15, 2024, and the other requirements of § 17-5-502 of the County Code;

18	WHEREAS, the Planning and Zoning Officer has provided the "School Utilization
19	Chart 2025" to the County Council by March 1, 2025; now therefore

21	SECTION 1. Be it enacted by the County Council of Anne Arundel County, Maryland,
22	That the "School Utilization Chart 2025", attached hereto as Exhibit A, is hereby approved
23	and shall take effect on the date this Ordinance takes effect.

25	SECTION 2. And be it further enacted, That this Ordinance shall take effect 45 days
26	from the date it becomes law.
