1 RESOLUTION selecting SC & H Group, an independent firm of certified public
2 accountants, to perform the financial audit for fiscal year 2025

4 WHEREAS, Section 311 of the Anne Arundel County Charter requires the County
5 Auditor to submit to the County Council and the County Executive, not later than
6 six months after the close of each fiscal year, a complete financial audit for the
7 preceding fiscal year of all offices, departments, institutions, boards, commissions,
8 corporations, courts and other agencies of the County government; and

10 WHEREAS, Section 311 of the Charter provides that, subject to the availability of
11 funds in the budget, the financial audit for the preceding fiscal year may be
12 performed by an independent firm of certified public accountants whose members
13 are licensed for the practice of their profession under the laws of this State; and

15 WHEREAS, Section 8-2-110(e) of the Anne Arundel County Code further provides
16 that the independent firm of certified public accountants retained to perform the
17 financial audit for the preceding fiscal year must be selected by resolution of the
18 County Council after receiving the recommendation of an Evaluation Committee
19 appointed by the Chair of the County Council; and

21 WHEREAS, Brenda Cachuela, Acting County Auditor; William Amos, Legislative
22 IT Audit Manager; and Charles Dike, Legislative Audit Manager were appointed
23 by the Chair to serve on an Evaluation Committee and recommended an
24 independent firm of certified public accountants to perform the financial audit for
25 fiscal year 2025; and

27 WHEREAS, the Evaluation Committee now recommends that SC & H Group, an
28 independent firm of certified public accountants licensed for practice in the State of
29 Maryland, be selected to perform the financial audit for fiscal year 2025; now,
30 therefore, be it

32 *Resolved by the County Council of Anne Arundel County, Maryland, That it hereby*
33 *approves the recommendation of the Evaluation Committee and selects SC & H Group, an*
34 *independent firm of certified public accountants licensed for practice in the State of*
35 *Maryland, to perform the financial audit for fiscal year 2025 as required by Section 311 of*
36 *the Charter; and be it further*
