A public meeting has been scheduled from 6:00 p.m. to 7:00 p.m. on Tuesday, June 17 via Zoom to discuss plans to replace pipes, valves and vaults on sections of the Parole Sewer Force Main, the Storch Property Force Main and the Annapolis Roads Force Main. The work is being done to enhance the sewer system's efficiency and functionality.

The work area, which is in the County and Annapolis City, will extend from 927 Bay Ridge Road to Edgewood Road to Breakwater Court in Annapolis. Work in the parking lot of a Gambrills restaurant is also included in this project.

Construction is scheduled to start in July and end in February. There will be lane closures at certain points along the route, with signs directing motorists through the area, and barriers. Work hours in the public right-of-way will be between 9:00 a.m. and 3:00 p.m. Monday through Friday, except on Bay Ridge Road. All work on Bay Ridge Road will be performed between 9:00 p.m. and 5 a.m.
