9	accounts for certain participants in the Police Service Retirement Plan and the Fire
10	Service Retirement Plan; modifying the employee contributions for certain participants

(a) Generally. A participant shall receive credited service for actual plan service in accordance with § 5-1-206; credited pre-plan military service in accordance with § 5-1-209; disability leave service in accordance with § 5-1-210; purchased service in accordance with § 5-1-211 OR § 5-1-212; and transferred service in accordance with §§ 5-1-301 et seq.

## **SUBTITLE 5. DEFERRED RETIREMENT OPTION** PROGRAM – FIRE SERVICE RETIREMENT PLAN, POLICE SERVICE RETIREMENT PLAN AND DETENTION OFFICERS' AND DEPUTY SHERIFFS' RETIREMENT PLAN

5-1-505. Limitation on the number of participants.

(a) Generally. Except as provided in subsections (b), [[and]] (c), AND (D), the number of employees who may begin participating in the DROP in a plan shall be limited to four new employees participating in each DROP plan as of the first day of any month.

(D) Fire Fighters, Fire Fighters/EMT-Paramedic, Fire Lieutenants, Fire Lieutenants/EMT-Paramedic, Fire Captains, and Fire Captains/EMT-Paramedic. SECTION. 3. And be it further enacted, That the provisions of this Ordinance shall apply retroactively to July 1, 2025.

SECTION 4. And be it further enacted, That this Ordinance shall take effect 45 days from the date it becomes law. 1
