 - Completed
 - Trim tree canopy
 - Completed





Traffic Operation Enhancements

Creation of No Thru Trucks over 5 Ton

- County will proceed with creating No Thru Trucks for Riedel Road
 - Phase 1 End of October (Completed) 0
 - Phase 2 Signs on SHA Road 0
 - Update: Memo and request submitted to SHA D5
 - No response from SHA as of June 10, 2025
 - Vegetation blocking signs trimmed
 - existing signage





- Short term
 - Lower speed limit to 30 mph (Supported by community) 74/35
 - Review existing speed signing placement and adjustment
 - Review existing warning signs
 - Completion by End of November 2024 Completed for Riedel Rd
 - Johns Hopkins Rd Developing speed limit change memo -Completion by end of March.
 - Update Memo completed. Created the Work Orders. Will need to coordinate with County Police for proper implementation.
 - Speed Limit Change completed









 - Will develop options for the road diet




