Greetings



Greetings!

As I continue my second consecutive term as the Anne Arundel County State's Attorney, I reflect on the past year and the accomplishments of our Office and partners in local law enforcement in keeping the people of this great county safe.

In 2024, our county saw a significant reduction in violent crime compared to the previous year, with decreases in homicides, carjackings, contact and non-contact shootings, and rape. Anne Arundel County police investigated 10 murders in 2024, the lowest in over a decade.

Despite this decrease, our prosecutors maintained a heavy workload of serious criminal and traffic cases in 2024. Early in the year, MTA Light Rail Operator Tavon Smith was sentenced to 18 months for a fatal crash that took the life of Lamar Paterson, a highly touted football prospect, as he drove to high school. This prosecution and the investigation by Anne Arundel County police revealed a lapse in protocol amongst MTA Light Rail operators, which created a crucial safety issue. Through this tragic case, missteps were uncovered. It is my hope Lamar's death will result in correction and greater enforcement of rules that will in turn, keep our community members safe.

In this 2024 Report, we take a moment to highlight some of the memorable cases and contributions our Office made to the Anne Arundel County community.

I am honored for the opportunity to serve as the leader of an Office composed of a dynamic team of attorney's, victim witness advocates, case managers, paralegals and investigators who work tirelessly and with such dedication to victims of crime.


Light Rail operator sentenced in crash that killed St. Frances football player in 2022

ANNAPOLIS, MD – MTA Light Rail Operator Tavon Smith was <u>sentenced</u> to 18 months for a fatal crash that took the life of highly touted football prospect Lamar Paterson as he drove to high school in February 2022, State's Attorney Anne Colt Leitess announced.

"It is MTA protocol that Light Rail operators must stop and dwell at each station for 30 seconds before proceeding," Leitess said. "It was determined the Defendant waited just a few seconds upon stopping at the previous station, so the safety gates didn't deploy in time to warn Lamar as he drove through the railway crossing at Maple Road in Linthicum. The Defendant also didn't heed the flashing cross warning indicator lights that notified him that the gates weren't down yet, and this combination led to the collision with Lamar's Honda. Had the Defendant followed the rules, this tragic death could have been prevented. The loss of a young man with a bright future is a tragedy for his family and his school community.

"This prosecution and the investigation by Anne Arundel County police revealed that MTA Light Rail operators may be disobeying protocol on this crucial safety issue because unless they stop for the required time at each station, the warning lights and gates simply do not have enough time to be deployed and warn motorists of an oncoming train. It is my hope that the story of Lamar's death will result in the enforcement of these rules, which are in place to keep our community members safe."

Man Sentenced to 10 Years. Lifetime on Sex Offender Registry, for Possession of Child Pornography

An Annapolis man received an active 10 year prison sentence and was ordered to register for his lifetime on the Maryland Sex Offender Registry for possessing more than 1,000 files of child pornography.

Keith Lionel Brown, 65, pleaded guilty to 10 Counts of Possession of Child Pornography in Anne Arundel County Circuit Court.

"The number of files containing child pornography found on the defendant's device is abhorrent and an eye-opening reminder that sexual crimes against vulnerable children are pervasive in and outside of our community," said State's Attorney Anne Colt Leitess.

Third-Time Felon
Sentenced to 25 Years
Without Parole for
First-Degree Assault of
Ex-Girlfriend

A Glen Burnie man who held his ex-girlfriend and their two children against their will over a two-week period was <u>sentenced</u> to 25 years in prison without the possibility of parole.

An Anne Arundel County Jury had found Juan Michael Pack, 40, guilty following a three-day trial.

"The victim has sought protective orders against the defendant because of this threatening behavior," Leitess said. "Despite those orders, he held the victim and their children for what must have been a very frightening and horrifying two-week period. I commend the victim for her bravery in not only finding a way to seek help, but for testifying at trial."

Man Sentenced to 15 Years in Fatal Drunk Driving Crash Outside Marley Station Mall

A Glen Burnie man was sentenced to 15 years in prison for driving while intoxicated, leading to a collision that left one man dead and others injured, including his 15-year-old nephew, outside Marley Station Mall.

In addition to prison time, Pedro Baires-Beltran, 36, was given five years of supervised probation.

"The defendant, who had a prior conviction and two pending DUIs, ignored all of the court-ordered conditions and once again drove intoxicated in the middle of the afternoon," Leitess said. "An innocent man lost his life... This sentence removes the defendant from our roads for many years.

Woman Sentenced to 30 Years for Fatal Shooting of Severna Park Man in Targeted Attack

A 33-year-old woman, who fled to Florida after fatally shooting a Severna Park father in an Annapolis community, was sentenced to 30 years in prison.

Ronnish Harris, of no fixed address, was sentenced to 60 years with all but 30 years suspended, with the first five to be served without the possibility of parole.

"This was a targeted shooting in broad daylight that not only took a man's life but also put small children and civilians at risk as they scattered for safety," Leitess said. "The defendant thought she could escape several states away, but due to efforts of the Annapolis Police Department and our partners with the U.S. Marshals, she was located and brought to justice."

Jury Finds Man Guilty of Sexually Abusing Minor in their Glen Burnie Home

Following a three-day trial, an Anne Arundel County jury found a Glen Burnie man guilty of sexually abusing a household member for several months when the victim was just 8 years old.

After one day of deliberation, the jury found Leonel Esquivel-Grijalva, 36, guilty of thirteen counts. Upon the verdict Circuit Court Judge Alison Asti revoked his bond and he was taken into custody.

"The defendant intimidated a child in his household and subjected her to months of sexual assault and abuse, which did not stop until he moved out," Leitess said. "It took years for the victim, now a teenager, to gather the courage to come forward... I commend her for her bravery."

Hanover Karate
Instructor Sentenced to
15 Years in Prison for
Sex Offenses Involving
Two Minors

A 72-year-old karate instructor was sentenced to 15 years in prison for sex offenses involving two minor children.

Harry "Craig" Conaway was also ordered to serve a mandatory five years of supervised probation and may not return to his Hanover home, where he ran his dojo. He was further ordered to have no contact with the victims or other minor children. He will be supervised by COMET and placed on a lifetime sex offender registry.

"As an instructor of martial arts, the defendant was expected to instill confidence and teach self-defense. As it turned out, the students needed defense against their own teacher who groomed and engaged them in sexual acts," Leitess said.

Severn Man Sentenced to 15 Years for Striking Three Pedestrians, Ramming SUV in Drunk Driving Rage

A Severn man was sentenced to 15 years in prison for striking three pedestrians with his vehicle and repeatedly ramming a parked SUV with two women inside after an altercation outside the Cancun Cantina.

In total, Adam Rey Wolford, 34, was sentenced to 75 years, with all but 15 suspended. He was ordered five years of supervised probation upon release.

"A bruised ego and intoxication led the defendant to use his vehicle as a weapon to target innocent victims whose lives were forever changed while simply trying to enjoy a summer evening with friends, "Leitess said. "This is more than a drunk driving case, and the sentenced ensures that he is held accountable.

Man Sentenced to 55
Years in Prison for
Murder, Attempted
Second-Degree Murder
at Edgewater Bonfire

A Crownsville man was sentenced to 55 years in prison for the fatal and non-fatal shootings of two men following an argument at a construction company's get-together.

In total, Wilber Oswaldo Nunez-Menendez, 28, was sentenced to 90 years with all but 55 years suspended, with the first 10 years to be served without the possibility of parole.

"This is yet another example of a verbal dispute escalating to gunfire, which claimed the life of a father and husband and critically injured another father and husband..."Leitess said. "The defendant fled the country in an effort to elude justice, but thanks to great efforts by law enforcement, and the surviving victim, the defendant will be held accountable for his crimes."

Man Sentenced to 40 Years in Prison for Fatal Shooting of Stepson Over Parking Dispute

A 71-year-old man was sentenced to 40 years in prison for the February 2023 fatal shooting of his adult stepson following an argument over a parking spot at their Brooklyn home.

The Honorable Kathleen Vitale sentenced George Albert Summers to 40 years with the first five year to be served without the possibility of parole.

"This is sadly another case where a verbal dispute turned deadly because of easy access to a firearm, the opposite of what was needed in this heated situation," Leitess said. "There is no excuse for a man to lose his life over something as trivial as a parking space, especially at the hands of his own stepfather. This sentence ensures the defendant will remain behind bars for the expected remainder of his life."

Man Sentenced to Life in Prison for First-Degree Murder of Mother at Tracy's Landing Home

An Anne Arundel County judge sentenced 26-year-old Andrew Beavers to Life in Prison for the first-degree murder of his mother, an accomplished cybersecurity executive, at their Tracy's Landing home.

Beavers had originally filed a Not Criminally Responsible Plea, claiming that he could not appreciate the criminality of his actions or control his contact due to a mental disorder.

"Despite having love and support, this defendant had assaulted his mother in the past and then ultimately ended her life," Leitess said. "His mother provided him with a place to live, a vehicle to drive, and only wanted the best for her son. This sentence holds him accountable for his actions and provides justice for Juanita Koilpillai's family and loved ones."

Man Sentenced to Four Years in Prison for Exposing Himself to Girls High School Track Team in Severna Park

A Glen Burnie man with a history of indecent exposures was sentenced to four years in prison for exposing himself to members of the Severna Park High School girls track team at an intersection.

Adam Sandow, 43, entered guilty pleas to all eight counts of Indecent Exposure. Upon release, he will be placed on five years of supervised probation, in which he is to have no contact with the victims of minors, and monitored by COMET.

"The defendant has a history of exposing himself to minors outside of schools and parks in our community and has been convicted of, and served time for these offenses," Leitess said. "He obviously learned nothing from these previous detainments and I am relieved he will serve a sentence at the Division of Correction.

Brooklyn Man Found Guilty of 2020 Murder in Annapolis Apartment Complex

Following a four-day trial, an Anne Arundel County jury found Jaden Crowner guilty of the murder of a 29-year-old man at an Annapolis apartment complex under the pretense of selling a smartphone to the victim.

Crowner, 20, was convicted of First-Degree Murder, Carrying a Firearm in Commission of a Crime of Violence, and other handgun offenses.

"Walters Elangwe was a hardworking man who flipped used smartphones for extra income. He was killed for no reason other than a desire by Crowner to test out his newly acquired handgun to rob the victim," Leitess said. "The defendant clearly has no regard for human life, and I am grateful the jury determined he was responsible for Mr. Elangwe's death.
