Re: Letter of Explanation for Variance Application

Cracker Barrel 175 Jennifer Road Annapolis, MD 21404

To Whom it May Concern,

We respectfully submit the following as a letter of explanation for three (3) variance requests for Cracker Barrel at the above referenced location.

### **Request One:**

Additional Wall Sign - We are requesting one (1) additional wall sign on the right (north) elevation for a total of three (3) signs on the building where two (2) are allowed by code (§ 18-3-308(b)(2)). The two (2) that are allowed by right will be on the front (west) and rear (east) elevations. This is a new building that would greatly benefit from enhanced visibility. Due to a curve in the road, the front (west) elevation main sign are not as visible as the right (west) elevation.

### **Request Two:**

The wall sign on the front (west) elevation that projects above the roof line - The parapet, which projects above the roof line, was specifically designed to accommodate signage, rather than being a general architectural element. This building design has already received County approval. As the provided renderings demonstrate, only a section of the wall sign will extend above the roof line. We are requesting a variance from the code (§ 18-3-303(b)(4)) to fulfill the original purpose of the extended parapet on the building's front elevation.

# Request Three:

A monument sign along Jennifer Road - A dedicated Cracker Barrel monument sign to be requested where no additional freestanding sign is allowed (§ 18-3-308(a)). A single tenant monument sign offers superior visibility for approaching traffic compared to smaller tenant panel signs. The curvature of the road reduces the view of smaller tenant panel signs, and a dedicated monument sign would significantly enhance commercial visibility.




Tenant Sign - 1 PANEL PER MONUMENT: 2 FOR SITE


