PUBLIC MEETING ANNOUNCEMENT

WHO: Anne Arundel County Department of Public Works (DPW)

WHAT: Environmental Modification, Bay View Force Main Replacement - Project #X7388324

WHEN: Tuesday, September 30, 2025 - 6:00 p.m. - 7:00 p.m.

WHERE: Edgewater Elementary School

A public meeting has been scheduled from 6:00 p.m. to 7:00 p.m. on Tuesday, September 30, 2025 at Edgewater Elementary School to discuss plans to replace the Bay View Sewer Force Main, which will help prevent sanitary sewer overflows.

The project will extend from: Shore Drive from the Bay View Pump Station to Shadyside Drive; Shadyside Drive from Shore Drive to Londontown Road; Londontown Road from Shadyside Drive to Havre De Grace Drive; Havre De Grace Drive from Londontown Road to Salisbury Road; Salisbury Road to Elkridge Drive; Elkridge Drive from Salisbury Road to Oakwood Road; Oakwood Road from Elkridge Drive to Mayo Road (MD 253); and Mayo Road from Oakwood Road to the Woodland Beach Sewer Pump Station.

During the meeting, DPW will discuss the necessary environmental modification in order to do this project. The modification is required due to temporary disturbance of wetland buffers under County Code Section 17-6-401 to be approved by the Office of Planning and Zoning.

Construction is scheduled to begin in spring 2026 and be completed by spring 2027. Work hours will be 8:00 a.m. to 4:00 p.m. Monday through Friday. There will be single lane closures during construction, with flaggers present to direct motorists through the work area. There will be no impact on water and sewer service.
