Brooklyn Park Needs Assessment



The Brooklyn Park Needs Assessment was created using quantitative and qualitative data. Quantitative data was collected from the U.S. Census Bureau, Maryland Report Card, Anne Arundel County Public Schools, and from our partners at the Health Department. The Community Quarterback, Partnership for Children, Youth and Families, is responsible for writing and researching the county's community needs assessment every three years. The most recent version, [Poverty Amidst Plenty](#) VIII was released on September 4, 2025, and is linked here. The relationships we have built across the county allows us to crosswalk multiple, quantitative, data sources and integrate existing insights with new data. Qualitative data was collected from those with local lived experience in Brooklyn Park through focus groups, interviews, and surveys in partnership with residents, youth and local, grassroots nonprofits. In all we collected data from over 850 residents.

Introduction

The eligible census tract for the ENOUGH initiative is 7502.0, the Pumphrey neighborhood within Brooklyn Park (Zip Code 21225). Brooklyn Park Community of Hope stakeholders agreed to extend the ENOUGH initiative boundaries to the four square miles of Brooklyn Park, North Anne Arundel County. The area shares a boundary with Baltimore City. The geographic boundaries of Brooklyn Park are bordered on the west by Route 684 (Baltimore Annapolis Boulevard), to the south of I-895 and the Patapsco River, north of I-695, and ending on the east at the Baltimore City line that crosses Route 2. Route 2, also known as Ritchie Highway, runs north and south through Brooklyn Park. It is a very busy, four lane highway with no safe place to cross. It acts as a barrier for cooperation between the neighborhoods on the east and west sides of the road. The county line between Baltimore City and Brooklyn Park runs right through a residential street. Increased residential mobility related to economic issues means that families

are constantly moving between Anne Arundel County and Baltimore City without any knowledge they have done so.

Brooklyn Park is composed of several smaller neighborhoods: Olde Brooklyn Park (west of Gov. Ritchie Highway – Maryland Route 2), Brooklyn Heights (east of Gov. Ritchie Highway), Arundel Village (along and north of Church Street), Roland Terrace (along and south of Church Street), Arundel Gardens (southwest of Gov. Ritchie Highway and south of Hammonds Lane), and Pumphrey, which lies along Belle Grove Road, south of the Patapsco River. The population was 34,469 according to the 2023 American Community Survey (U.S. Census, 2023).

Brooklyn Park continues to be an extremely diverse area. The African American population is still the highest demographic but the Hispanic community is growing faster than all other races and ethnicities (See Table 1 below).

Brooklyn Park (zip code 21225) has over four times the poverty rate of the rest of the county at 22.3 percent. The Pumphrey census tract of Brooklyn Park has a child poverty rate of 35 percent, according to the most recent US census data (U.S. Census American Community Survey, 2023). There are at least six rising socio-economic indicators of need in Brooklyn Park, including the percent of families living at or below poverty, percent of the population without a high school diploma, the percent of households receiving food stamps (SNAP), the emergency department visit rate, the percent of low birth weight infants, the preventable hospitalization rate and the percentage of minorities (Table 2). The entire area is classified as a food desert and a childcare desert (Anne Arundel County Department of Health, 2024). Life expectancy is fifteen years shorter for residents of Brooklyn Park than it is for those in Arnold, just 15 miles down the road (Figure 13).

Brooklyn Park is located in the watershed of the non-tidal portion of the Patapsco River. The sub watersheds that include Brooklyn Park have high levels of impervious surface, a low percentage of forest cover and low water quality that does not meet federal Clean Water Act standards. The primary water quality impacts are from excessive inputs of nutrients (nitrogen and phosphorus) and sediments (Anne Arundel County Department of Health, 2025). Brooklyn Park has a tree equity score of 72 out of 100, which is the lowest in the county, whereas Severna Park has a tree equity score of 96 (American Forests Tree Equity Score, 2021). Trees can play a significant role in the health of people, as tree covers provide shade and help cool neighborhoods. Lower temperatures also mean lower energy consumption and lower electricity bills.

Secondary Data by ENOUGH Pillar

Economically Secure Families

The highest percentage of poverty in Anne Arundel County is in the zip code that contains Brooklyn Park at 22.3 percent (more than 4 times the rate of the county average). Economic security is hampered by lack of childcare, lack of transportation, lack of internet access and low healthy food access, all of which act as barriers to a living wage.

Median Household Income, Anne Arundel County, 2023

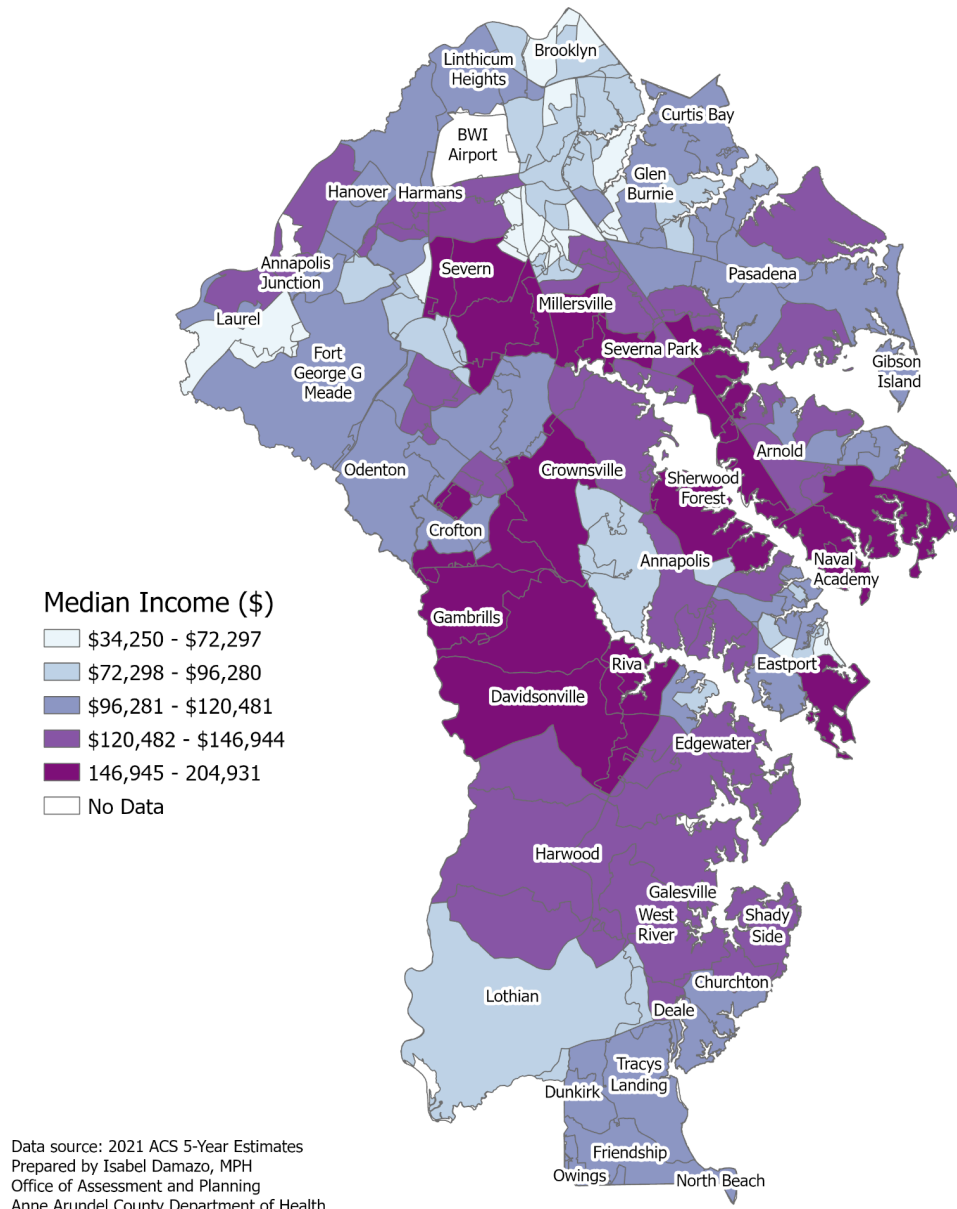
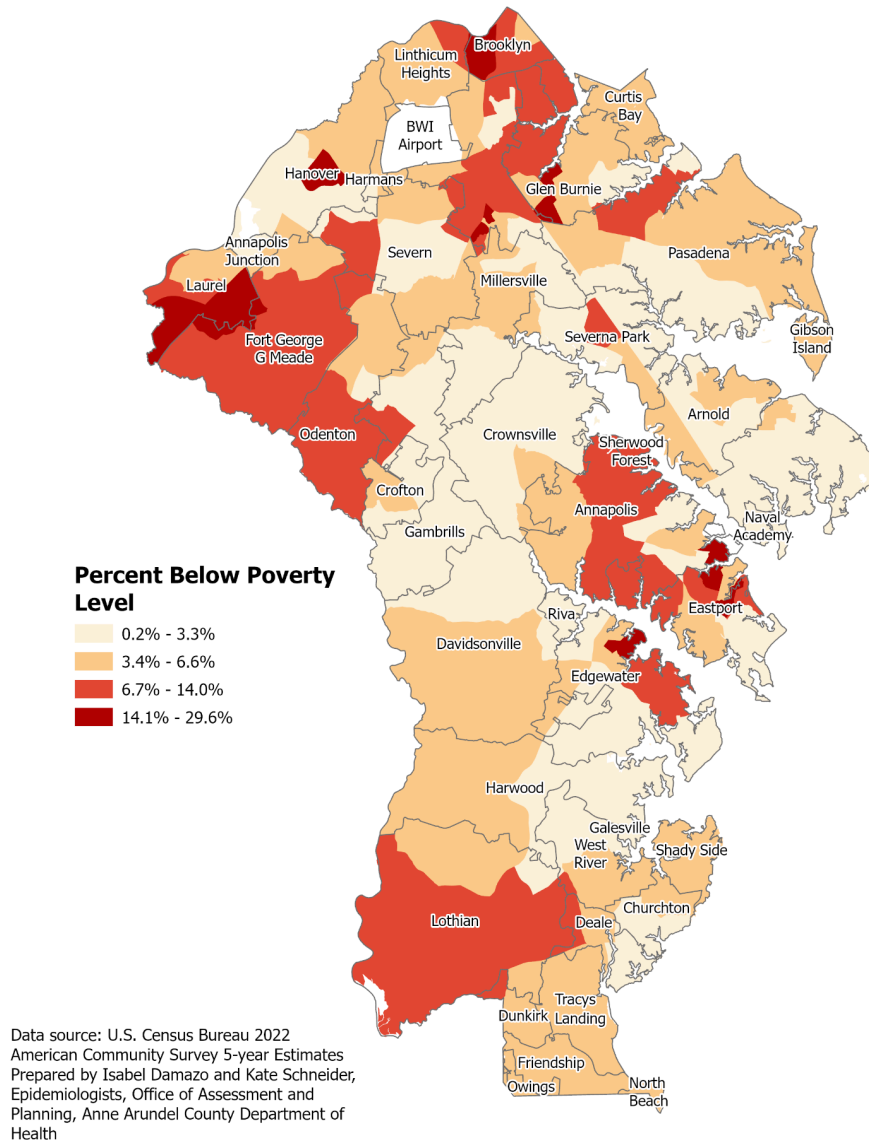


Figure 2: Percent of Population with Income Below Poverty Level, Anne Arundel County, 2022

Pumphrey Census Tract

In the Pumphrey census tract, 40.1% of those under 18 are in poverty with an overall poverty rate of 22.7%. The median income is \$65,279.

Brooklyn Park has a higher percentage of renters. Of those renting, many find themselves rent overburdened, meaning that they spend more than 30 percent of their income on housing (Table 5).

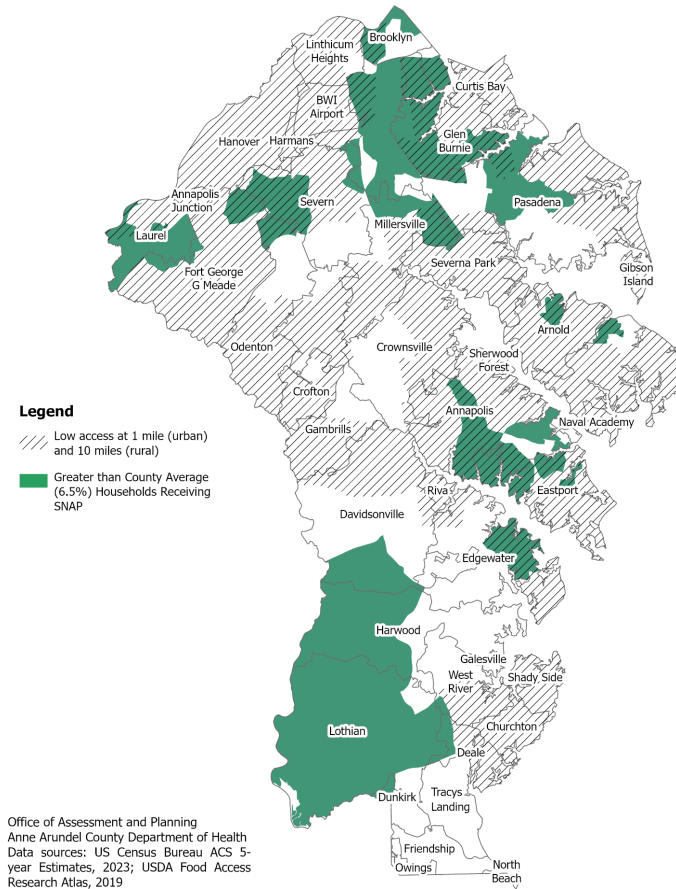

Food

Almost 25.7% or 3,326 households receive food stamps (SNAP) (U.S. Census American Community Survey, 2023). The entire area is classed as a food desert; defined as an area without ready access to fresh, healthy and affordable food. There is one grocery store (Save-A-Lot) in Brooklyn Park and many residents rely on convenience stores and fast food options.

Internet Access in Brooklyn Park

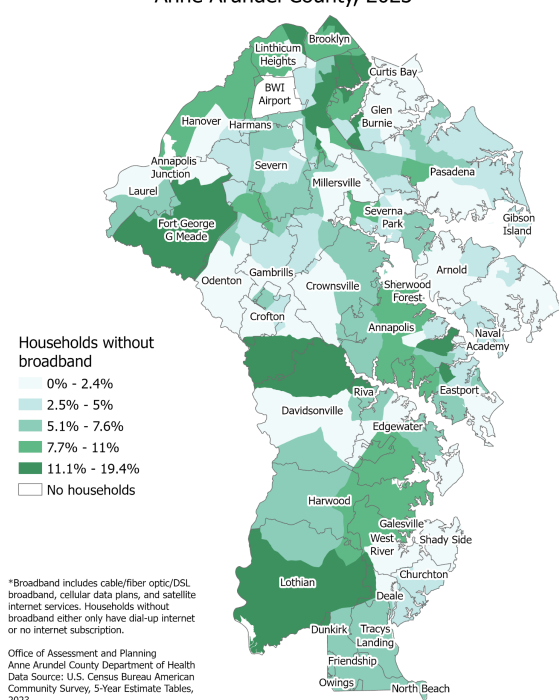
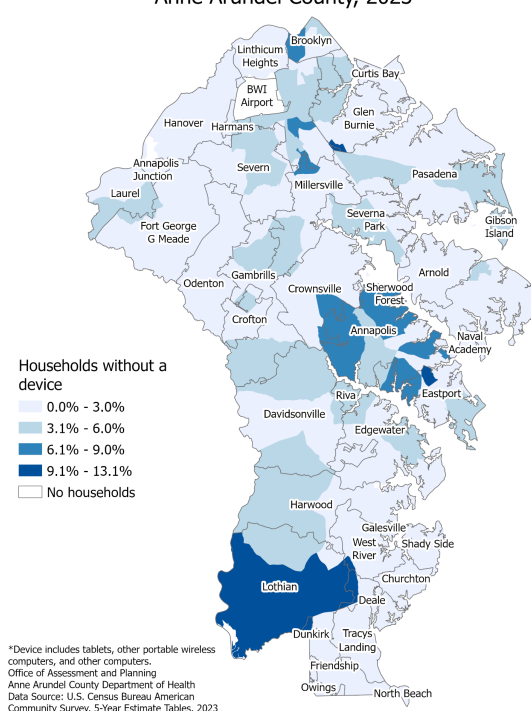


Figure 5: Households Without A Device* by Census Tract, Anne Arundel County, 2023

According to research, internet access increases neighborhood economic mobility by connecting people to higher-paying jobs, online education, entrepreneurship opportunities, and essential services like telehealth and government assistance. Expanding broadband access and training promotes workforce development and economic growth in underserved communities. Census tracts in Brooklyn Park are among the highest for households without a device and lowest for access to Broadband (Figures 4 and 5).

Households Without Broadband* by Census Tract, Anne Arundel County, 2023

Households Without A Device* by Census Tract, Anne Arundel County, 2023

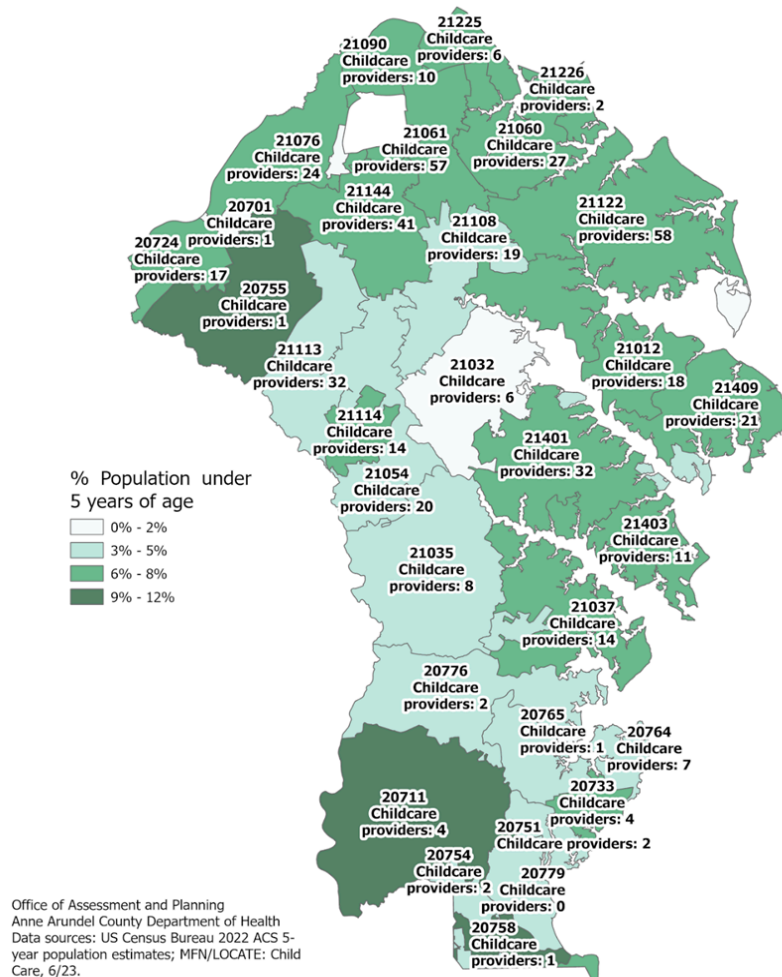


Number of Childcare Providers in Brooklyn Park

Brooklyn Park is a childcare desert and has the lowest facility and family childcare numbers in the county (Figure 6). There is one Head Start center at Lloyd Keaser Community Center, one childcare center and four family childcare providers. The lack of childcare creates issues for low income families where caregivers and sometimes older siblings need to work to ensure the family is economically stable.

Transportation

While Brooklyn Park is one of the most densely populated areas in the county, it has very few resources and services. Previously, there was only one bus route in Brooklyn Park, the number 69, that ran hourly and was not connected to employment routes. There have been small improvements like the addition of route number 70 that runs from Baltimore to Annapolis, and the county has added the Brooklyn Park connector, a small route from Brooklyn Park to Ferndale, connecting to the Cromwell Light Rail station in Glen Burnie. While there are improvements to transportation, it is still a struggle for those living in the area as many families either have no car or a shared vehicle that is old and unreliable. In Brooklyn Park, only 2 percent of residents work at home as opposed to the county average of 23 percent. That means residents are spending more dollars on childcare and transportation (Tables 7 and 8).

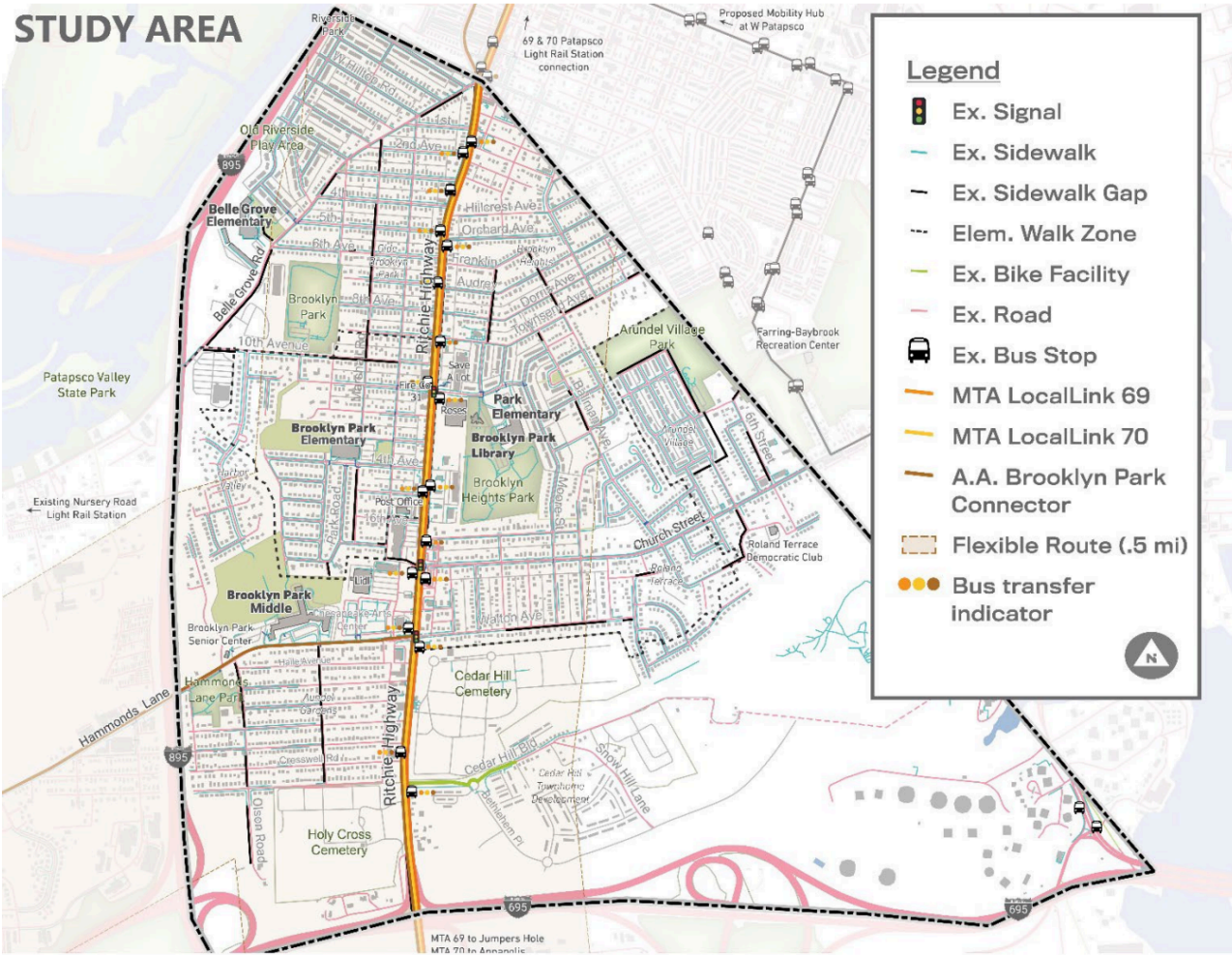

Sidewalk issues in Brooklyn Park

Participants in this needs assessment commented on the lack of well-maintained sidewalks for families who need to walk for food, to take their children to school and to access appointments. (Figure 7). There are no school buses for elementary and middle school because the schools are within the 1.5-mile radius required by the public school system for a school bus pick up. Anecdotally, this increases the chronic absence rate - especially in winter.

Healthy Families Pillar

Prenatal to 5

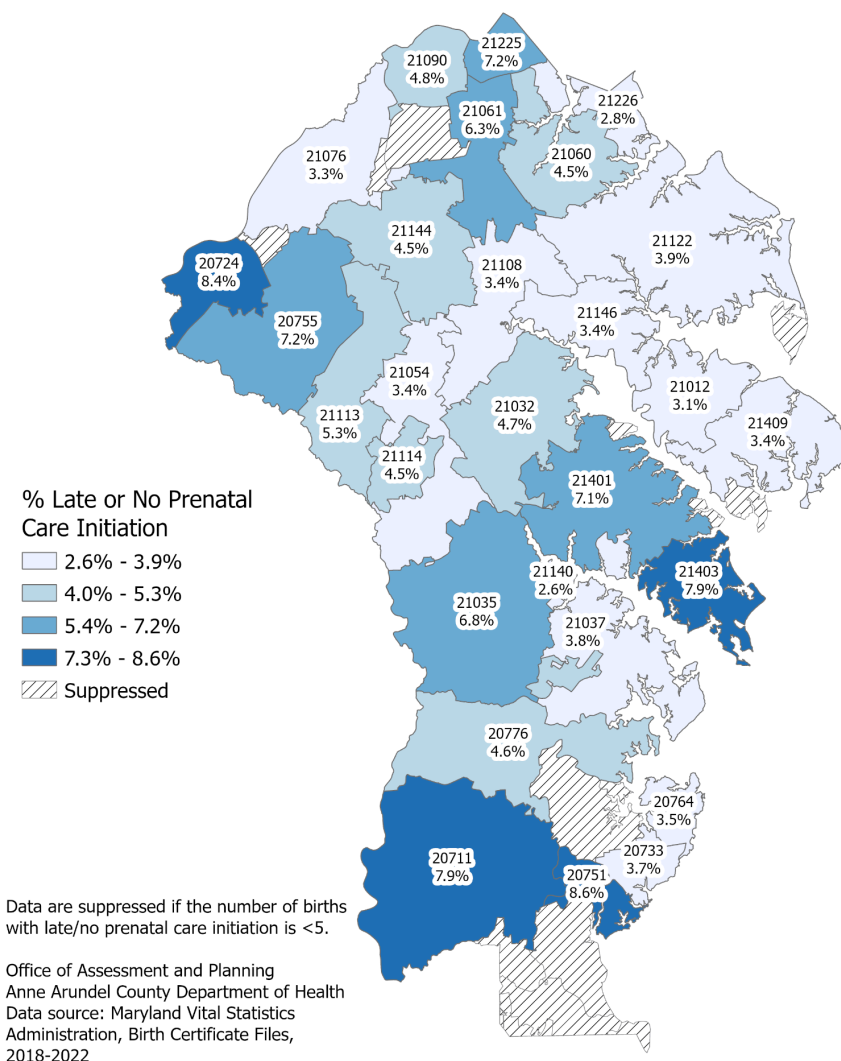


Figure 9: Above County Proportion of Births with Low Birth Weight (<2500 grams) by Zip Code, Arundel County, (2018-2022)

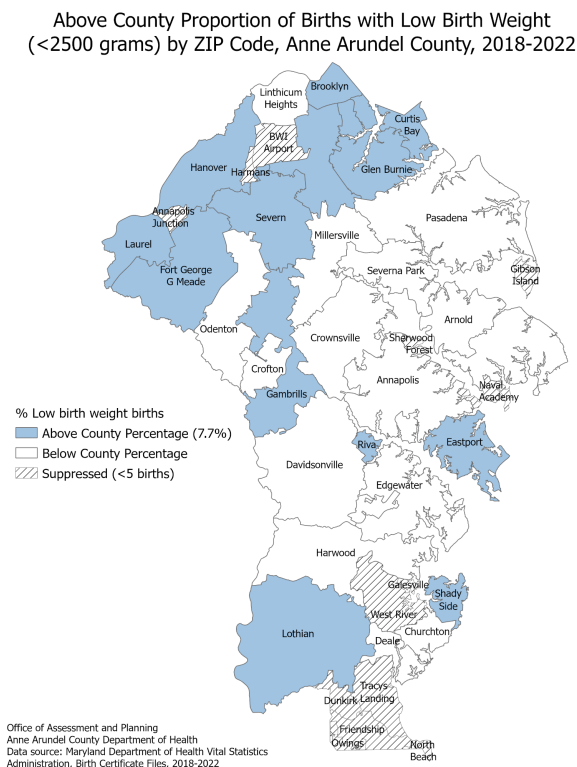
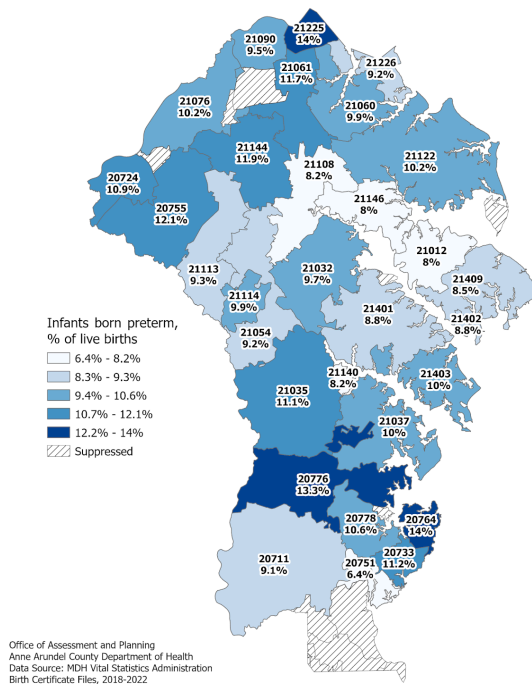


Figure 10: Infants Born Preterm (<37 Weeks of Gestation) by Zip Code, Arundel County, (2018-2022)

Brooklyn Park has the worst prenatal to 5 years old outcomes in the county, according to the most recent maternal health report completed by the Anne Arundel County Department of Health in 2025. The proportion of live births with late or no prenatal care is the highest in the county (Figure 8). The zip code has a 12% low birth weight compared to 7.7% for the County and highest rate of preterm births is 14% (Figures 9 and 10).

Anne Arundel County, 2018-2022

Environmental issues further inhibit the healthy development of Brooklyn Park children. The childhood lead registry shows that children in the Brooklyn Park zip code have five times the lead in blood levels compared with Severna Park children, our wealthiest zip code (Table 9).

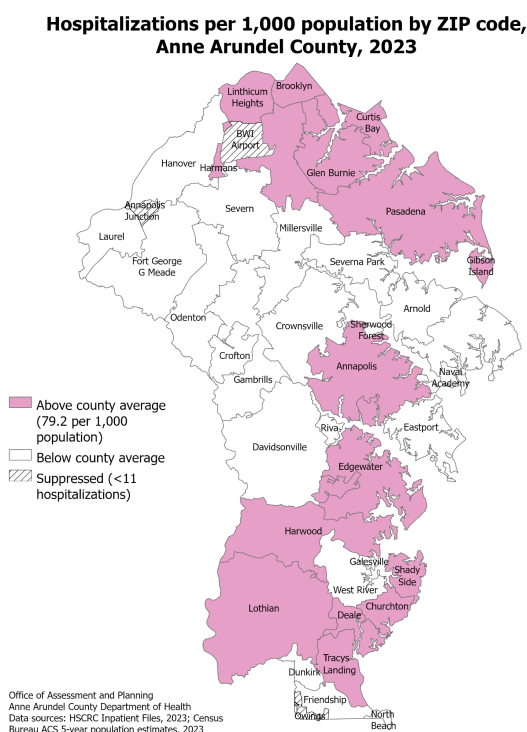

General Health Care

The nearest hospital in Brooklyn Park is Harbor in Baltimore. The lack of primary care and the rising social determinants of health for the neighborhood generally result in less preventive medicine and more hospital visits. When patterns of hospitalization are examined by ZIP code (Figure 11), they generally reflect the social determinants illustrated in Table 2. Zip code 21225, which contains Brooklyn Park, has the highest hospitalization rate of anywhere else in the county, most likely due to the lack of accessible primary health care and therefore lack of preventative care. Residents may wait until their health issue is more serious to seek care, especially those without access to health insurance. The only federally approved health center closed over six years ago. There are now two urgent care facilities. In 2025, Total Health Care opened a Federally Qualified Health Clinic in Brooklyn, less than two miles from Brooklyn Park, which will offer more health resources to Brooklyn Park residents, including primary care.

Figure 11: Hospitalizations per 1,000 Population by ZIP code, Anne Arundel County, 2023

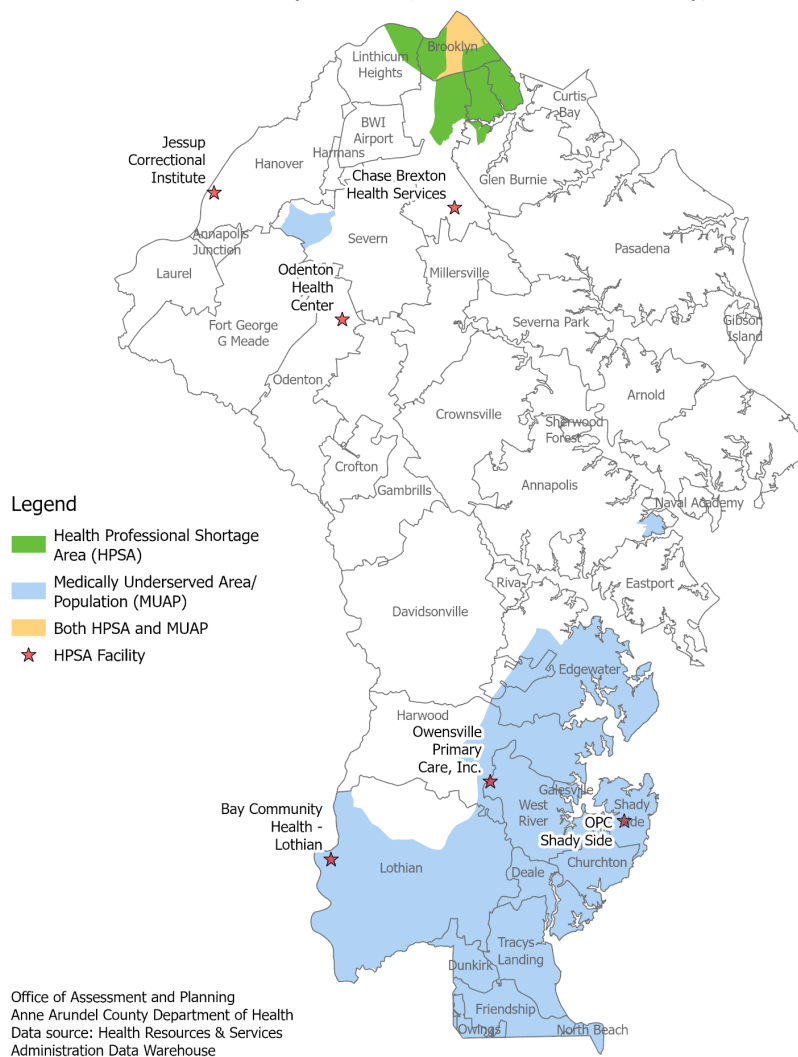


Health Professional Shortage Areas

Health Professional Shortage Areas (HPSAs) are designated by the Health Resources and Services Administration (HRSA) as having shortages of primary medical care, dental or mental health providers and may be geographic or facility-based. Brooklyn Park is both a Health Professional Shortage Area and a Medically Underserved Area (Figure 12).

Medically Underserved Areas (MUAs) are designated based on four variables: ratio of primary medical care physicians per 1,000 population, infant mortality rate, percentage of the population with incomes below the poverty level and percentage of the population age 65 or over.

Substance Use

Substance Use is significantly more prevalent in neighborhoods like Brooklyn Park, often driven by a complex mix of risk factors and systemic inequities. Residents face chronic stress, economic instability, and limited access to healthcare, which creates a destructive cycle where poverty increases the risk of substance use, and addiction deepens poverty. Brooklyn Park has the third highest incidence of fatal and non-fatal opioid overdoses in the county (Table 10). It is among the top six areas in the county that have residents receiving state supported aid for substance and/or alcohol treatment. There are very few behavioral health facilities. In fact, most human services, including eligibility for benefits, public housing and workforce development, are located in Glen Burnie; a distance of almost 8 miles. There is already a treatment center in Brooklyn Park on Richie Highway. Community residents expressed the need to fix the underlying issues related to poverty rather than add more treatment centers to their neighborhood.

Life Expectancy

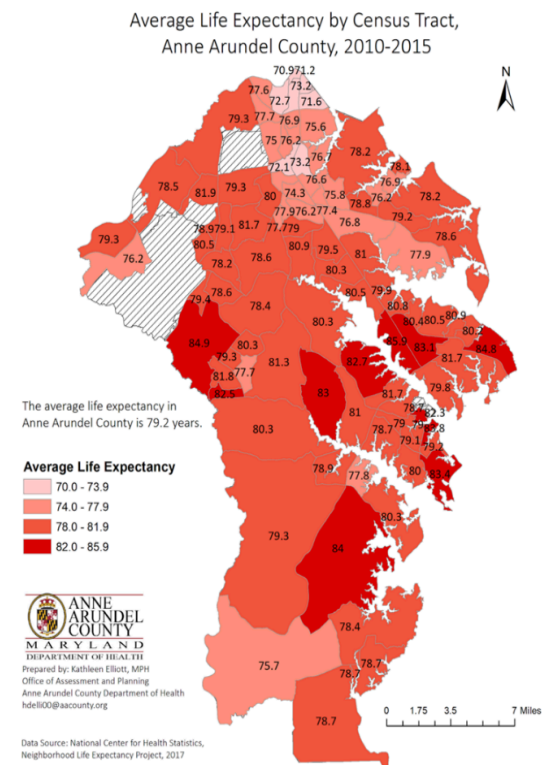


Figure 13: Anne Arundel County Average Life Expectancy by Census Tract, 2010-2015

Given the low prenatal care, birth outcomes, environmental issues and lack of health care, it's not surprising that life expectancy is lower in Brooklyn Park. According to the University of Florida Department of Physiology and Aging (2024), access to healthcare is one of the important indicators of life expectancy because it increases the likelihood of detecting and treating health conditions early. In contrast, those living in rural areas or without insurance are less likely to seek treatment, whether for preventative care or to address current health conditions. Other researchers have noted that factors such as poverty, food insecurity, and lack of access to education and employment opportunities can negatively impact health and life expectancy. According to the Robert Wood Johnson Foundation (2025), where we live may affect our chances of living a long, healthy life. Life expectancy can be up to 15 years longer for a resident living in Arnold as opposed to someone who lives in Brooklyn Park (Figure 13).

K-12 Information

Brooklyn Park Schools

Belle Grove Elementary School serves the Pumphrey and Olde Brooklyn Park communities. As with the other Brooklyn Park schools, the student population is very diverse (Table 14 below). As well as being a community school, Belle Grove also has a Judy Center. Park Elementary serves the communities on the east side of Ritchie Highway (Brooklyn Heights and Arundel Village). Brooklyn Park Elementary serves students in the Arundel Gardens neighborhoods. Third grade test scores are low for all elementary schools, especially Brooklyn Park Elementary (Tables 12 and 13).

The designated community school in the Pumphrey Census Tract, Belle Grove, is highly diverse with a growing Hispanic population (Table 14). The mobility rate at the school is highest for the African American community (Table 15).

Students are considered habitually or chronically absent if they are absent for 20 or more days during the school year. Students who miss more than 20 days of school in preschool, kindergarten, and first grade are much less likely to read at grade level by the third grade. Students who cannot read at grade level by the end of third grade are four times more likely than proficient readers to drop out of high school. According to Gubbels, van der Put, and Assink (2019), missing 10 percent or more of school for any reason (excused, unexcused or suspensions) in kindergarten leads to worse achievement in later grades. The impact was greatest on the children living in poverty with less resources to make up for lost time to learn in the classroom. Maryland Report Card shows percentages of not chronically absent, rather than percentages of chronically absent. However, it is clear that the chronic absence rate between 25 and 35 percent increases at the middle and high school level to almost 40% (Table 16).

Brooklyn Park Middle School serves all children in Brooklyn Park. The 2024 eight grade proficiency tests show that under half the students are scoring at the proficient level in English, and only 5% of eighth grade students are scoring at the proficient level in Math.

North County High School serves Brooklyn Park children. When comparing overall school scores with Severna Park High School (situated in one of our wealthy neighborhoods) it is clear how the social determinants of health impact every level of success for Brooklyn Park children, including academic achievement and post secondary success. Only 64 percent of North County High School students are on track to graduate (Marland Report Card, 2025). The higher percentage of children with less than a high school education in Brooklyn Park is clearly illustrated in figure 14.

Homeless Youth

According to the National Network for Youth (2025), youth from low income neighborhoods, where there is a lack of safe spaces and social support, are more likely to become homeless. The numbers of homeless youth in each Anne Arundel County Public Schools cluster follow the same geographic pattern as other social determinants of health for the county and is unevenly distributed. The numbers are higher in school feeders that cover zip codes that are disproportionately African American and low income (Table 20). The North County Feeder System, which includes the Brooklyn Park zip code, has the most homeless youth at 219, an almost 21 percent increase since 2022 (Table 20 and Figure 15).

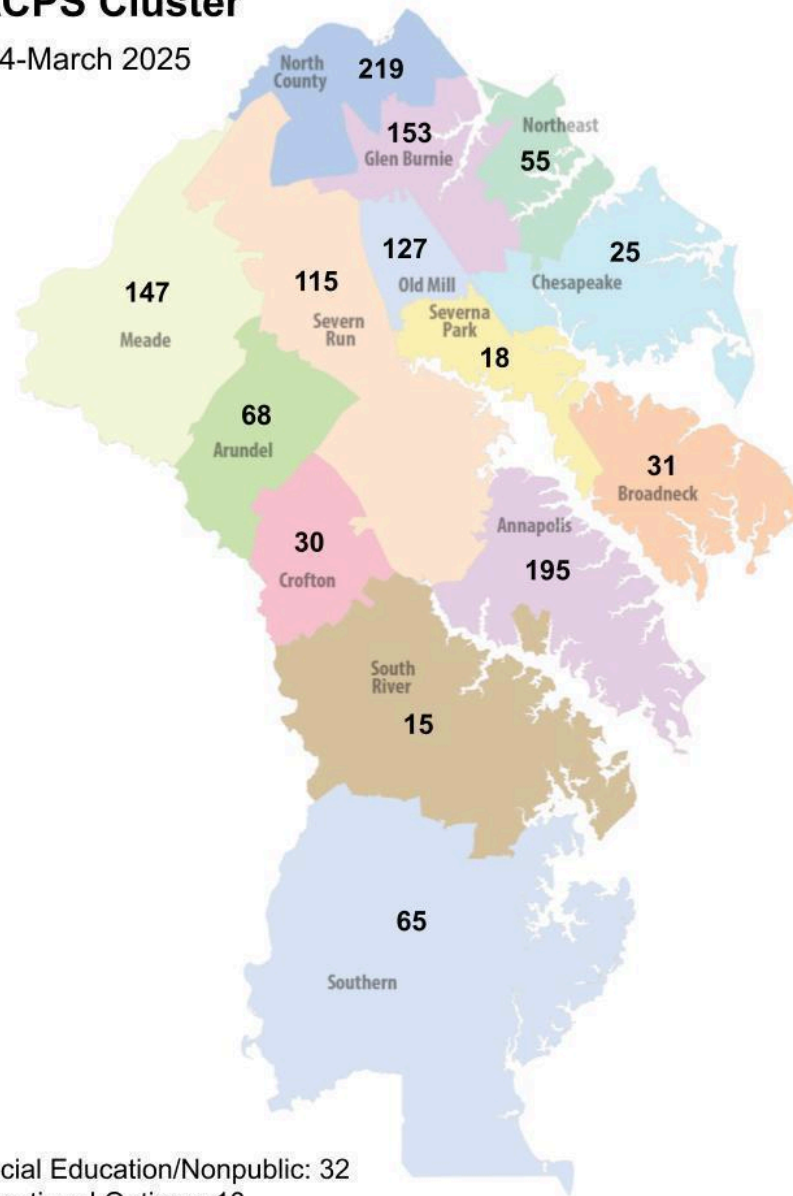

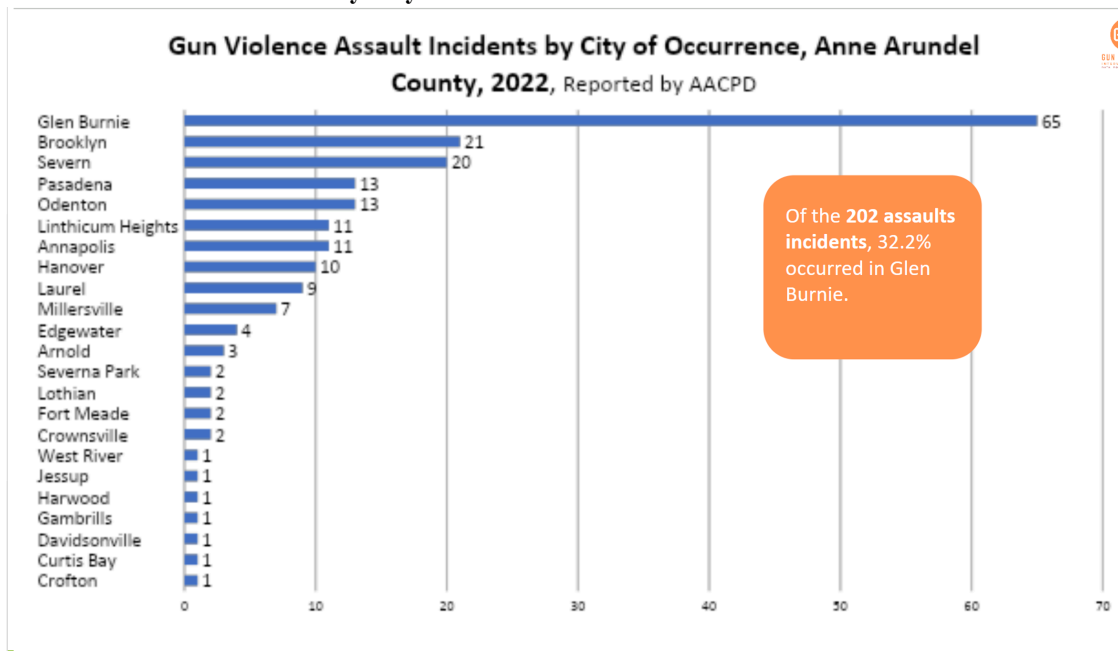
Brooklyn Park is in Police District 2, which has the highest arrest rate in the county. The Anne Arundel County Department of Health, through its Gun Violence Intervention Team (of which the Partnership is a member) has been tracking recovered gun and ERPO data. For both issues, North District is far higher than the rest of the county (Table 21). The Gun Violence Intervention Team has asked Cure Violence to conduct an assessment in Northern Anne Arundel County to determine if a Violence Interruption Program could be successfully implemented and 78 youth participated in a survey on school and community violence. The results will not be available until October 2025 but youth stressed the need for prevention measures, youth involvement and school based programming.

Brooklyn Park has the second highest rate of gun violence in the county (Figure 16) yet many community residents said they felt safe in their community and neighborhood.

Figure 17: Sidewalk and Road Safety - Pedestrians and Drivers

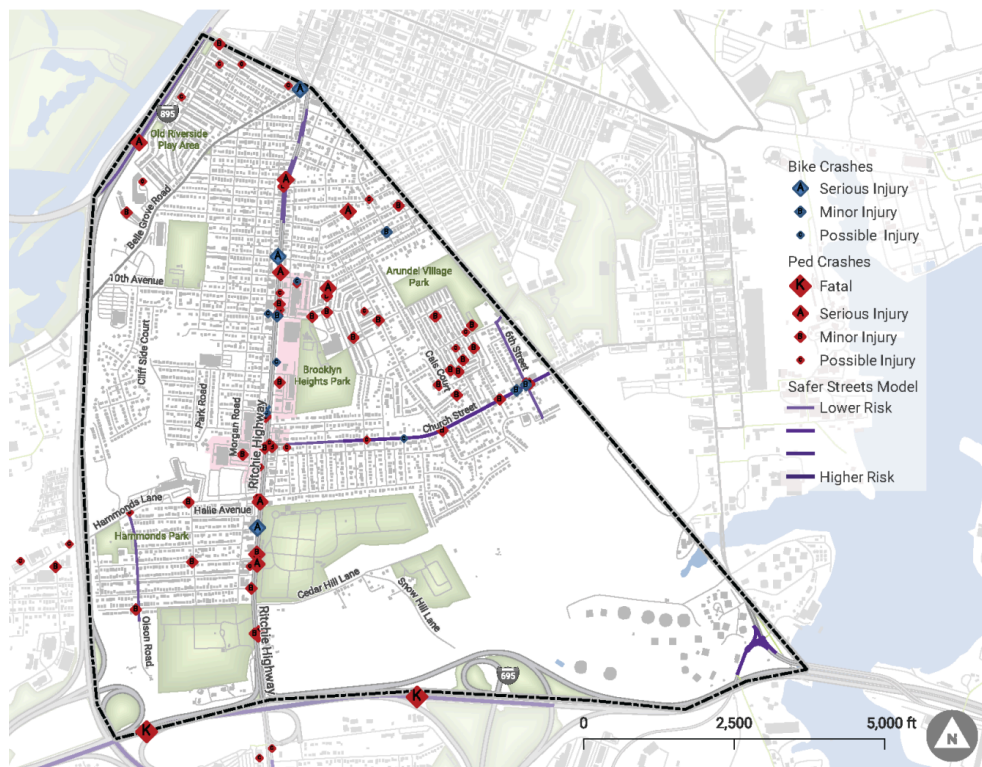


Figure 23 SSPF and Bicycle and Pedestrian Crashes by Severity

Environmental Issues

Brooklyn Park is located in the watershed of the non-tidal portion of the Patapsco River. The sub watersheds that include Brooklyn Park have high levels of impervious surface, a low percentage of forest cover and low water quality that does not meet federal Clean Water Act standards. The primary water quality impacts are from excessive inputs of nutrients (nitrogen and phosphorus) and sediments. Brooklyn Park has a tree equity score of 72 out of 100, which is the lowest in the county, whereas Severna Park has a tree equity score of 96 (American Forests Tree Equity Score, 2021). Trees can play a significant role in the health of people, as tree covers provide shade and help cool neighborhoods. Lower temperatures also mean lower energy consumption and lower electricity bills.

One of our Youth Committee members, Jordan Plange, spent the summer looking at issues related to rainfall and bacteria in the water, particularly in neighborhoods like Brooklyn Park with poor and older sewer systems and made the comparison with some of the issues in Flint, Michigan. Brooklyn Park Needs Assessment Qualitative Section - What the Residents Said



Introduction

Using economic mobility and child poverty outcomes, we used open ended questions to gauge the opinions of residents of every age and race/ethnicity from a fourth grade class at Park Elementary to senior residents in the historically Black community of Patapsco Park/Pumphrey. Data collection began with our kick off meeting on January 23, 2025 and has continued over the last six months. Leadership team members used their own connections to hold neighborhood meetings and to talk with their neighbors. Our not-for-profit groups talked to youth and residents

they were connected to through their programming. We held focus groups with youth in afterschool programs. We gathered information at community events, food pantries and at community school meetings. We completed RBA turn-the-curves with the Leadership Team. Overall, using open-ended questions, we have gathered the opinions of over 850 residents related to improvements to the built environment, how to reduce poverty, and how to move residents to economic prosperity. The data came in through the following methods: handwritten on paper, in video format, in Excel spreadsheets, typed in Word and on turn-the-curve format. All data was read and reread using qualitative research techniques to search out families of data then themes. Overall, Brooklyn Park residents, young and old, like living in Brooklyn Park. It is quiet and peaceful, they know their neighbors, there's a sense of community, and some stores are walkable. Some had a sense that the neighborhood was part of Anne Arundel County, others described the area as a "suburb of Baltimore" or "South Baltimore." [Here is a file link to raw data collected.](#)

Brooklyn Park – Themes emerging from what they said

Youth

- **Give kids opportunities for sports:** Soccer, football, basketball court, volleyball, swimming - basically any sport
- **Things for kids to do:** Playground - especially with swings, indoor outdoor park, more community activities, field trips, roller skating, swimming pool (note lack of air conditioning mentioned several times)
- **Afterschool & weekends:** Tutoring, how to make money and be successful, student social hour, groups for young men, financial literacy
- **Services:** Transportation, Walmart, Air-conditioners, chrome books
- **Safety:** Police cameras
- **Barriers to success:** Driving schools cost, can't get to driving school.
- **Career:** No career readiness center, need help for those who don't see college in their future, access to apprenticeships. Need training help for cosmetology, hair, nails, streaming and social media
- **Opportunities for entrepreneurialism,** small business
- **Traffic Safety:** Roads are very dangerous. Hard for youth to play outside.
- **Food:** Community Kitchen at the Community Center to bring families/community together, turn old metro buses into mobile grocery stores

Adults

- **Connecting adults to livable wage jobs**
- **Affordable, accessible childcare**
- **Focus on jobs with a living wage for young adults new to the workforce:** training for youth: business workshops, tutoring, work study programs, financial management programs, coaching, apprenticeships

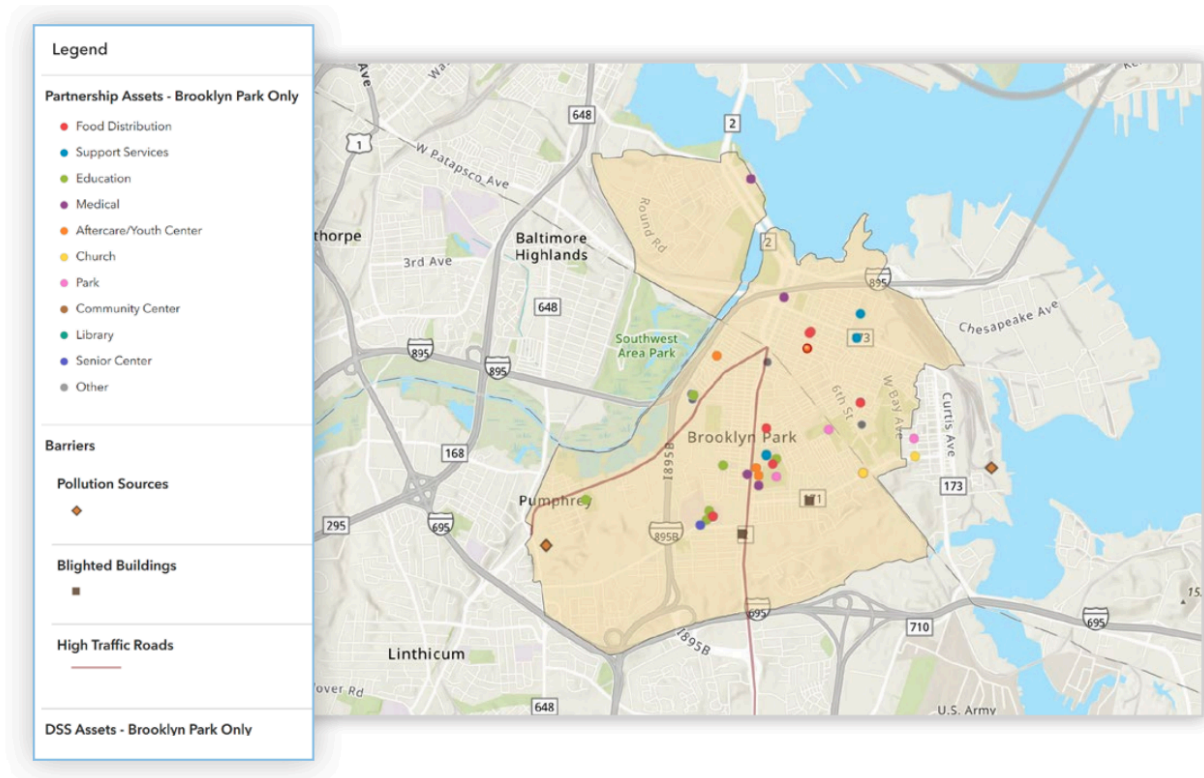
- **Soft skills:** Soft Skills, Money Skills, and Computer skills is mission critical for our neighbors (Youth Job Seekers)
- **0-5 population:** Free childcare, Pre-K, Headstart, Early Head Start
- **Things for youth to do:** After school, field trips, summer programs
- **Youth Life Coach:** Case management geared toward youth to fill in gaps that are missing in a single parent home or home with substance abuse, mentoring relationships who are bilingual and paid

Asset and Resource Mapping

The asset mapping for this project is an ongoing process that began in 2024 and uses several mechanisms to ensure that it is driven by community members, while incorporating ongoing engagement from critical partners and stakeholders. Needs assessment and asset mapping is an iterative process which will continue for the life of the project

- Initial inventory compiled by the partners in our Board and Guiding Coalition as part of our strategic planning sessions at the end of 2024.
- Assets were layered into a digital map with filters for specific asset types (like support services, education, parks, food distribution, church, medical, aftercare/youth center, library, community center, senior center, etc.).
- [Asset map](#) shared several times with Brooklyn Park Community of Hope members, ENOUGH leadership team and resident council
- Community and non-profit partners in the ENOUGH initiative began outreach to community members through local events, meetings, and community walks to gather information on resources not identified in the first iteration of the map, and to gather further details on intangible assets and resources that might be included in our inventory.
- Each iteration was reviewed by our Partner Team, Leadership Team, Resident Council and Youth Committee to ensure that our asset inventory and map were as comprehensive as possible and accurately reflected the community's collective assets and resources.
- Due East consultants worked with the Department of Social Services and the Behavioral Health Hub to overlay their services onto the asset map as part of their own planning processes. All 3 layers can be viewed separately or combined onto [a single, countywide asset map](#).
