Dear Chief Wolford.

My name is Scott Katzen and I am the medical director of AAMC's cardiac cath lab. I am writing this email to inform you how impressed I was with your teams from Arnold and Cape St. Claire yesterday 9/1/2025. In case you were not aware, there was an out of hospital cardiac arrest in the community of Ulmstead that involved a colleague/physician after he had just participated in the neighborhood triathlon. I rushed over to his house after seeing your crew pass the finish line of the race and the team was already at work. The individual was in his foyer, pulseless, and was already receiving high quality CPR. I have been involved in numerous codes in my career and none are easy from an emotional perspective. I cannot tell you how impressed I was with the members who were there performing lifesaving resuscitative measures. The team was lead by Kathy Winter and EMS supervisor Dave Carrier. The efforts were in my opinion methodical and flawless. From their interpretation of the patient's cardiac rhythm, to securing his airway, to gaining access for therapies, to drug administration, to even timing of cycles between rhythm/pulse checks, it was amazing to see. They are well trained and prepared. Despite the ultimate negative outcome for this patient, I was beyond impressed with their skill which in my opinion was heroic. I for the majority of the time receive critically ill patients from the paramedics after they have been cared for in the field prior to taking them for emergent cardiac catheterization and to watch these providers work at an individual's home, in a tight space, and mind you doing it in front of two physicians (myself as well as the patient's wife who is an ER doctor) was simply extraordinary. In summary, you should be proud of Kathy, Dave, and all of the others who were there (I apologize for not having each of their names) and am honored to be part of this fantastic team which starts with you all.
